Background

Each local government is responsible for carrying out the requirements and responsibilities of the *Health Act 1911* within its district, and enforcing the provisions of the Act. It is practical for the local government to appoint a person to be its deputy, so that Council does not need to deliberate on every action taken under the Act.

Scope & Limitations

Applies to the local government's functions under the *Health Act 1911*, and under those regulations and local laws made under the *Health Act 1911*.

Policy

The Chief Executive Officer, the Director Community Development and Manager Health Service are appointed as the local government's deputies under Section 26 of the *Health Act 1911*. These appointments are to remain in place until revoked by Council.






Proposed Outbuilding (Shed) Lot 87 (3) Coldwell Road, Wattle Grove Floor Plan
