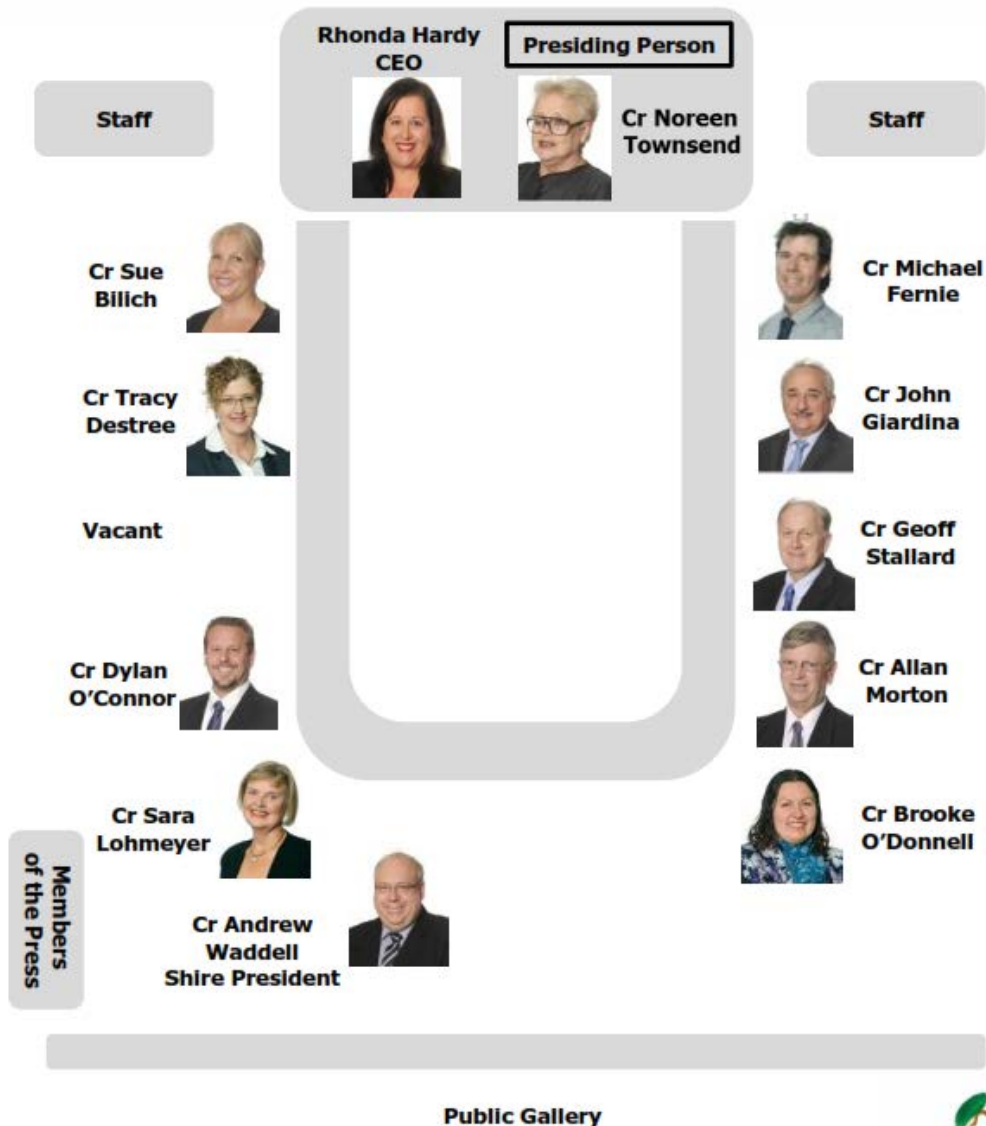

A period of not less than 15 minutes is provided to allow questions from the gallery on matters relating to the functions of this Committee. For the purposes of Minuting, these questions and answers will be summarised.

3.1 Questions taken on Notice from the Corporate & Community Services Committee Meeting held on 15 May 2017.

Mr David Downing, 107 Milner Road, High Wycombe (Summary of Debtors)

Q1. Why was the original question on March 20, taken on notice, answered in such an incorrect manner?

A1. We have reviewed the response provided to the question of 20 March 2017 and acknowledge that more information providing a chronological sequence would have assisted in explaining the reason for the re-issuing of the Developer Contribution invoice.

One of the reasons for the reissue of the invoice was due to the discovery by the Shire of an error in the contribution rate which was calculated at a rate of \$31.23 rather than \$29.66 per sqm. Contributions were then correctly collected at \$29.66 per sqm to account for the 50% lower cost of Sultana Road West which was originally charged at 100%.

The Shire opted to treat the refund as an offset against the larger debt owed rather than retaining the debt based on a rate of \$31.23. Either option would achieve the same financial outcome and were both acceptable accounting practice. Had the Shire opted to collect a rate of \$31.23 per sqm, it would then have had to reimburse the debtor for a portion of Sultana Road West at a rate of \$1.57 per sqm (\$1.57 is the difference between the contribution rates of \$31.23 and \$29.66).

The Shire was in legal negotiations with Mr Letizia for the recovery of the outstanding debt when advice was received from the Shire's lawyers to retain the rate of \$31.23 per sqm (adjusted to \$29.66) due to the legal agreement having already been drafted and subject to in principle support. To re-issue the invoice at the revised rate of \$29.76 per sqm would cost approximately \$2,000 compared to the \$1,300 difference between the two contribution rates. Additionally, re-issuing the invoice would most likely result in further delays in collection of the debt.

Over the period of a number of months, different calculations were transacted to allow for changes in the contribution rates, adjustment for payments made and adjustments for GST. The Shire is happy to provide a complete reconciliation outlining each of the adjustments undertaken.

- Q2. Is this the acceptable level of integrity at the Shire of Kalamunda when questions asked in this chamber can be answered in such a manner?
- A2. The scheme is complex with a number of variables and subject to high levels of community scrutiny. Shire staff are committed to managing the funds within the scheme in a professional manner and the scheme is subject to the usual levels of oversight and audit review. Adjustments to the Scheme typically relate to timing issues and year-end adjustments identified through scheme reviews and following audit.

The Shire understands the high level of interest from the community and always attempts to answer questions in an open and accountable manner. Questions asked on notice are not always easily answered particularly when they involve a number of transactions over several months. Notwithstanding, the Shire is firmly committed to working with the Community to ensure that answers to questions regarding the scheme are answered in accurate fashion.

It is acknowledged that during the previous years there have been various issues regarding the scheme resulting in frustration to Scheme Owners. The Shire accepts that at times human errors have been made, however, these have not been wilful nor deceitful. The Contributions Scheme is subject to external audit and the Auditors have not identified any fundamental integrity issues with the administration of the Scheme.

In order to improve the level of trust between land-owners the Shire is willing to work closely with owners to address any questions or concerns raised. Development Services staff are happy to establish regular meetings with land-owners in order to work through any questions or issues that arise.

EXECUTIVE SUMMARY

1. To receive the Rates Report for the month of May 2017 provided to Councillors on request.
2. The report provides a status on the rates collection percentage and any recovery actions being undertaken.

BACKGROUND

3. Rates notices were issued on 11 July 2016 with the following payment options:-

4. A total of 23,571 Rate Notices were sent on 11 July 2016. Rates Levied and Collectable for the 2016/17 Financial Year currently total \$35,034,613. Of this amount, \$33,271,367 has been collected as at 31 May 2017. This represents a collection rate of 96.32% which is only slightly below the collection rate of 96.55% in the 2015/16 Financial Year. The collection rate has normalised over the last month and is expected to improve again towards the end of financial year.
5. A total of 9,242 ratepayers have taken up an instalment option this year. Of these, 1,924 have taken up the option to pay by two instalments and 7,318 have taken up the option to pay by four instalments.
6. Three additional services have been introduced in recent years to better assist ratepayers in paying their amounts due. These are:
 - A Smarter Way to Pay – to date approximately 623 ratepayers have signed up.
 - eRates – To date there are 1,971 properties signed up for electronic delivery. This represents approx. 8% of the rates database;
 - BPay View – To date 158 ratepayers have signed up for this service.

7. Raising of Interim Rates for the 2016/17 financial year has begun with \$508,231 being raised to date. Interim Raising has ceased for the 2016/17 Financial Year and will be resumed following the 2017/18 due date.

DETAILS

8. There were 97 properties with outstanding claims for the 2015/16 and previous years that were put on hold pending the approval of the Debt Recovery Policy which was finalised in May 2016. These have now been included in the Final Notice run and will be absorbed into the 2016/17 Debt Recovery process.
9. The Shire has begun debt recovery with the sending of a Final Notice to all accounts with a balance owing of more than \$50 where the account is not paying by instalments, a Direct Debit or other arrangement. The Final Notices were sent on 11 November and fell due on 25 November. While the response has been good, a Letter of Demand was sent to 510 properties on 27 March 2017 with a due date of 10 April 2017. A call/email campaign is being finalised before legal action is taken to recover any remaining debts, as per the Debt Collection Policy.
10. There are now only two properties in the Shire with amounts outstanding since 2012/13. One property has been sent to the lawyers for a PSSO (Property Seizure and Sales Order) re-issued on the Land in line with the Council Debt Collection Policy and is now proceeding through lengthy Court and Landgate processes. The other was contacted in January 2017 to request contact as a last effort before the PSSO-Land is issued. An amount of \$2,000 was paid towards the debt but further repayments and an attempt to come to a debt recovery arrangement have failed. The debt will now go through as a default and the collection process will resume. Councillors will be briefed before the bailiff places the properties on auction.

STATUTORY AND LEGAL CONSIDERATIONS

11. The Shire collects its rates debts in accordance with the *Local Government Act 1995 Division 6 – Rates and Service Charges under the requirements of subdivision 5 – Recovery of unpaid rates and service charges.*

12. The Shire is bound by the Debt Collection Policy S-FIN02.

15. The early raising of rates in July has allowed the Shires operations to commence without delays in addition to earning additional interest income.

OFFICER COMMENT

22. The Shire's debt collection strategy has proven to be very effective with a 97.79% collection rate in the 2015/16 financial year. While it is noted the May 2017 collection is still slightly lower than previous years collections, debt recovery will continue until end of financial year to increase the collection as much as possible.

EXECUTIVE SUMMARY

1. To receive the list of payments made from the Municipal Accounts in May 2017 in accordance with the requirements of the *Local Government (Financial Management) Regulations 1996 (Regulation 12)*.
2. To receive the list of payments made from the Trust Accounts in May 2017 in accordance with the requirements of the *Local Government (Financial Management) Regulations 1996 (Regulation 12)*.
3. To receive the outstanding debtors and creditors reports for the month of May 2017.
4. Trade Debtors and Creditors are subject to strict monitoring and control procedures and in the month of May 2017 there were no abnormal overdue debtors that demanded special attention with the exception of one debt related to the developer contribution scheme (see note 9 below).

BACKGROUND

5. Council has requested reports detailing outstanding debtors and creditors on a monthly basis.

6. Sundry debtors as of 31 May 2017 were \$409,020 of which \$151,907 was made up of current debts and \$2,450 unallocated credits (excess or overpayments).

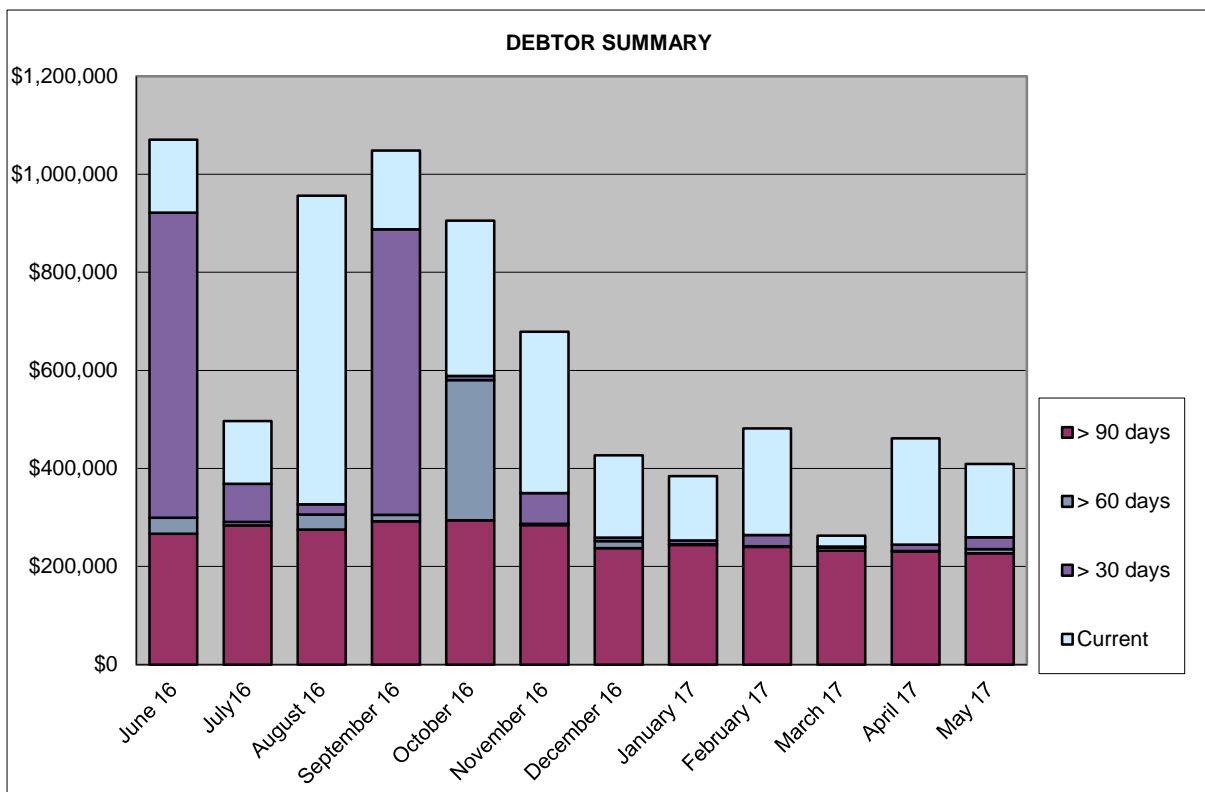

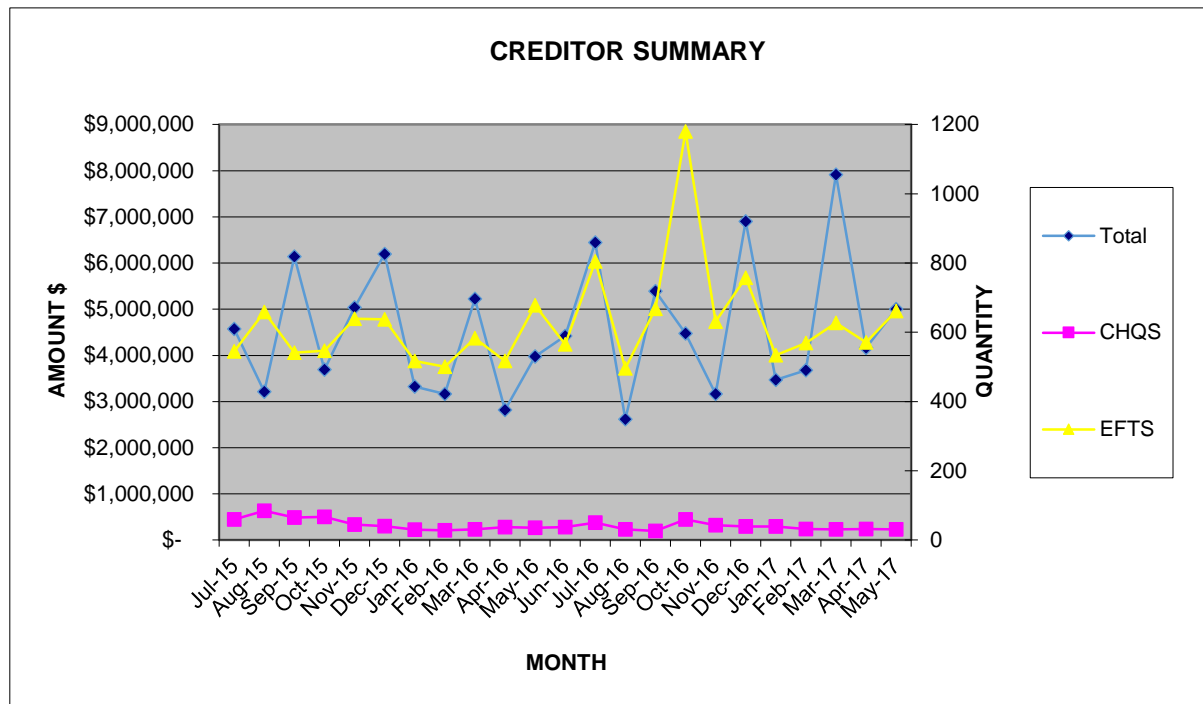

EXECUTIVE SUMMARY

1. To receive the Draft Monthly Statutory Financial Statements for the period to 31 May 2017, which comprises:
 - Statement of Financial Activity (Nature or Type) for the eleven months period ended 31 May 2017
 - Statement of Financial Activity (Statutory Reporting Program) for the eleven months period ended 31 May 2017
 - Net Current Funding Position, note to financial statement as of 31 May 2017.
2. To provide Council with statutory financial reports on the activity of the Shire of Kalamunda with comparison of the year's performance against the revised budget adopted on 27 March 2017. This Statement compares the actual results for the period with the revised budget.
3. The Shire's draft financial statements as at 31 May 2017 demonstrate the Shire has managed its budget and financial resources effectively.

BACKGROUND

4. The Statement of Financial Activity (Attachment 1), incorporating various sub-statements, has been prepared in accordance with the requirement of the *Local Government Act 1995*, Regulation 34 of the *Local Government (Financial Management) Regulations 1996*.
5. The opening funding position in the Statement of Financial Activity reflects the audited surplus carried forward from 2015/16.
6. The budget column reflects the budget approved subsequent to the mid-year budget review by Council at its meeting on 27 March 2017.

DETAILS

7. The *Local Government Act 1995* requires Council to adopt a percentage or value to be used in reporting variances against Budget. Council has adopted the reportable variances of 10% or \$50,000 whichever is greater.

Financial Commentary

Draft Statement of Financial Activity by Nature and Type for the eleven months ended 31 May 2017

8. This Statement reveals a net result surplus of \$17,041,049 compared to budget for the same period of \$16,079,298. The majority of the variance of \$961,750 is in the areas of land and building & infrastructure projects and reserve transfers.

Operating Revenue

9. Total Revenue excluding rates is over budget by \$737,972. This is made up as follows:
- Operating Grants, Subsidies and Contributions are over budget by \$875,936. The variance is arising from contributions received from Cell 9 for infrastructure works worth \$1,387,215. This income is offset by amounts shown in capital expenditure as work in progress worth \$1,514,218.
 - Fees and Charges is under budget by \$292,068. The variance is mainly attributable to:
 - Legal charges from general procedures claims from rates debtors which is under budget by \$142,558. While the debt recovery process commenced on 27 March 2017, the Shire is yet to start the legal action. Correspondingly, the expenditure side shows an underspend of \$152,314 in debt collection expenditure.
 - Rates miscellaneous income is under budget by \$126,718.
 - Interest Income is over budget by \$153,222. This is primarily a timing matter with the majority of term deposits maturing in May 2017.
 - Other Revenue is under budget by \$10,834. This variance is within the reporting threshold.
 - Ex-Gratia rates revenue is above the budget by \$5,522 as the amount from Co-operative Bulk Handling (CBH) and Dampier Bunbury Gas pipeline has been received. The Shire is currently in negotiations with CBH to draft a new agreement affective from 1 July 2017.

Operating Expenditure

10. Total expenses is over budget by \$424,613. The significant variances within the individual categories are as follows:
- Employment Costs are under budget by \$186,411 which is primarily due to vacant positions not filled, phasing of casual and project based salaries and timing of training programmes scheduled for the last quarter of 2017.
 - Materials and Contracts is over budget by \$1,759,315. This is mainly attributed to Forrestfield Industrial Area and Cell 9 expenditure. The amounts paid for Forrestfield Industrial Area Scheme Stage 1 and Cell 9 were reimbursed by drawing against the reserve and trust fund respectively set aside for it.
 - Utilities are under budget by \$189,411 which is mainly related to street lighting costs being under budget by \$105,996. The variance is mainly due to budget phasing as in the summer months the operating time is less than in the coming winter cycle. It should be noted that savings from the installation of the PV panels commenced during May with approximately \$5,000 in realised savings identified so far.
 - Depreciation, although a non-cash cost, is tracking under budget, reporting a variance of \$12,657. This variance is within the reporting threshold.
 - Interest expense is under budget by \$7,466. This is a result of a timing difference between amounts accrued and the budget which is based on the debenture payments schedules.
 - Insurance expense is under budget by \$20,815. The variance is within the reporting threshold.
 - Other expenditure is under budget by \$889,420. This relates mainly to Forrestfield Industrial Area Scheme Stage. The amounts paid for Forrestfield Industrial Area Scheme Stage 1 were reimbursed by drawing against the reserve set aside for it.
 - Loss on disposal of Assets is under budget by \$25,131. The variance is within the reporting threshold.

Investing Activities

Non-operating Grants and Contributions

11. The non-operating grants and contributions are over budget by \$529,303. The variance is mainly due to:
- Contributions for capital works under CELL 9 projects is over budget by \$535,169. The Shire recognises an amount equivalent to capital work in progress as capital contribution for projects under CELL 9.

Capital Expenditures

12. The total Capital Expenditure on Property, Plant and Equipment and Infrastructure Assets is under budget by \$4,294,642. A large part of this has now been identified as a carry forward for the new budget 2017/18. The funds will be placed in the appropriate reserves in June to allow for the works to continue into the new year.
13. Capital work-in-progress of \$1,514,218, represents the costs expended on Forrestfield Industrial Area Scheme Stage 1 and CELL 9 Wattle Grove development. The relevant expenditure is funded by the Forrestfield Industrial Area Scheme Stage 1 reserve account and the CELL 9 trust account. These assets once constructed will be passed over to the Shire for management.

Financing Activities

14. The amounts attributable to financing activities shows a deficit of \$2,805,146 which is due to reserve movements. The movements are explained in detail in point 23 below.

Rates revenues

15. Rates generation is over budget with a variance of \$329,424. The variance is due to the receipt of interim rates income.

Draft Statement of Financial Activity by Program for the period ended 31 May 2017

16. The overall result comments are as above and generally each Program is within the accepted budget except for Other Property and Services, Community Amenities and Recreation and Culture. Major variances have been reported by Nature and Type under points 8 to 15 above.

Draft Statement of Net Current Funding Position as at 31 May 2017

17. The commentary on the net current funding position is based on comparison of the draft May 2017 to the May 2016 actuals.
18. Net Current Assets (Current Assets less Current Liabilities) show a result of \$25.434 million. The restricted cash position has a balance of \$11.1 million which is lower than the previous year's balance of \$12.6 million. This can mainly be attributed to the transfers from reserves in anticipation of infrastructure works projects and Forrestfield Industrial Area Scheme Stage 1 works progressing.
19. Trade and other receivables outstanding comprise rates and sundry debtors totalling \$2.8 million.

The rates balance increased by \$0.1 million from last year which reflects increases in rates generation related to various factors including interim rates, back rates and the differential rate increases. The balance was anticipated to reduce significantly with the first instalment date on 16 August 2016 however, it has been observed that the collection rate is tracking slightly lower than 2015/16.

This is attributed to more ratepayers choosing to pay by either instalment options or direct debit payment arrangements. The impact of this is cash inflow will be drawn out rather than the bulk being received in the first two months of the financial year.

20. Sundry debtors have decreased from \$1,181,712 to \$409,020, of which \$151,907 consists of current debt due within 30 days. A total of \$223,862 remains outstanding over 90 days. The majority of this debt consists of an outstanding developer contribution for the Forrestfield Industrial Area Scheme Stage 1. These overdue amounts are currently subject to recovery action.
21. Receivables Other represents \$1 million comprising:
- Emergency Service Levy receivables \$0.26 million
 - Receivables sanitation \$0.33 million
 - GST (purchases) \$0.39 million.
22. Provisions for annual and long service leave have decreased by \$111,960 to \$2.7 million when compared to the previous year. The reasons for the decrease is due to the Shire aggressively pursuing a leave management plan without adversely affecting service delivery. The long term goal is to bring this liability down to a more manageable level and also ensure there are adequate cash backed reserves in place to support it.
23. Restricted Reserves have decreased from \$12.3 million to \$11.1 million when compared to May 2016. The decrease is due to the following:
- Forrestfield Industrial Area Scheme Stage 1 has decreased by \$1.6 million. With commencement of its major capital projects amounts has been drawn down from the reserve to meet the necessary funding requirements.
 - Minor changes are also noted with the following reserves:
 - Asset Enhancement Reserve has increased by \$0.2 million.

EXECUTIVE SUMMARY

1. To consider an amendment to the current Shire of Kalamunda Council meeting structure.
2. At the Ordinary Council meeting on 29 May 2017, Council resolved to request a report from the Chief Executive Officer on advantages, disadvantages, financial implications and administration implications of introducing an alternative meeting structure.
3. The analysis of the requirements has raised no significant issues arising from an alternative structure and amendments have been recommended.

BACKGROUND

4. The Council has considered its meeting structure a number of times in recent years and tried a number of different meeting structure options.
5. These have included:-
 - Changing the meeting night for both of the main Committees
 - Changing the meeting night for the Ordinary Council meeting
 - Introduction of Strategic Briefing sessions
 - Introduction and abandonment of Agenda Briefing sessions based on Committee Agendas

Full details are shown in Attachment 1.

DETAILS

6. At the Ordinary Council meeting on 22 May 2017 (RESOLVED OCM 81/2017), Council Resolved:-

*That Council:
Request the Chief Executive Officer prepare a report for consideration by Council at the June Ordinary Council Meeting on advantages, disadvantages, financial implications and administration implications of introducing an alternative meeting structure which incorporates:-*

- *A Strategy Briefing Session*
- *Open Agenda Briefing Session, and*
- *Ordinary Council Meeting*

7. An analysis of 11 other metropolitan local government meeting structures has revealed there are a number of different structures utilised, including:-

- Five have a similar committee structure to Kalamunda feeding into an Ordinary Council meeting on a monthly basis.
- One has a similar committee structure to Kalamunda, however these feed into to two Ordinary Council meetings a month.
- Four have an Agenda Briefing meeting feeding into an Ordinary Council meeting on a monthly basis.
- One has two Ordinary Council meetings a month and no Agenda Briefing meeting.

Only one of these local governments had information on their website with respect to having a monthly Strategy/Briefing meeting.

8. From an administration perspective, there would be minimal implications should the meeting structure be amended to abolish the Development and Assets Services (D&A) and Corporate and Community Services (C&C) Committees and introduce a monthly cycle of Agenda Briefings and an Ordinary Council meetings.

9. The main point of consideration would appear to be timing of the Agenda Briefing prior to the Ordinary Council meeting. All of the local governments mentioned in point 8 above have their Agenda Briefing in the week prior to the ordinary meeting.

10. A decision will also need to be made as to the allowable community participation in an Agenda Briefing meeting with respect to Public Question Time, talking to individual items and deputations. All local governments analysed have differing community participation options.

STATUTORY AND LEGAL CONSIDERATIONS

11. Section 5.3 of the *Local Government Act 1995* provides that a council can have ordinary meetings and may hold special meetings, with ordinary meetings to be held not more than 3 months apart.

12. Section 7.1A of the *Local Government Act 1995*, stipulates that a local government is to establish an Audit Committee.

24. A draft schedule of agenda briefings and Council meetings based on the above is detailed in (Attachment 2).

- Possible benefits:
 - No significant additional time demands,
 - More efficient use of councillors and meeting time,
 - Better timeframe for Strategic Briefings, particularly for issues of a complex nature or community concern,

 - Resource/time savings for Administration.
 - Possible issues:

EXECUTIVE SUMMARY

1. To consider the community comments received in relation to the review and drafting of Kalamunda Advancing: Strategic Community Plan 2017-2027.
2. At the Ordinary Council Meeting on 27 March 2017, Council resolved to advertise for public comment the draft Kalamunda Advancing: Strategic Community Plan 2017-2027.
3. This report recommends minor amendments to the draft Kalamunda Advancing: Strategic Community Plan 2017-2027 (the Plan) following the receipt of community comment as well as adoption of the Plan.

BACKGROUND

4. In 2010, the Integrated Planning and Reporting (IPR) Framework and Guidelines were introduced in Western Australia (WA) as part of the State Government's Local Government Reform Program. All local governments were required to have their first suite of IPR documents in place by 1 July 2013.
5. The format for the IPR Framework and Guidelines have been developed to:
 - Ensure community input is explicitly and reliably generated.
 - Provide the capacity for location specific planning where appropriate.
 - Update long term objectives with these inputs.
 - Identify the resourcing required to deliver long term objectives.
 - Clearly convey long term financial implications and strategies.
6. The minimum requirement to meet the intent of the Department of Local Government and Communities (Department) is the development and adoption of:
 - A Strategic Community Plan.
 - A Corporate Business Plan.

-
7. Other key plans suggested are known as informing plans under the IPR and included but are not limited to:
 - Long Term financial Plan
 - Workforce Plan
 - Information technology Plan
 - Community Engagement Strategy
 - Asset Management Plan
 8. An Advisory Standard published by the Department refers to the minimum regulatory requirements as well as “Achieving”, “Intermediate” and “Advanced” Standards of IPR performance. In the lead up to July 2013 when the IPR regulatory requirements came into effect, and since, local governments have been steadily working to meet the regulatory requirements. The Shire has undertaken a self-assessment against the standard and believes it has achieved advanced standard for the ongoing development of the Plan.
 9. The Shire of Kalamunda adopted its first edition strategic community plan titled Kalamunda Advancing: Strategic Community Plan to 2023 (“Kalamunda Advancing”) which is intended to shape the priorities for the Shire over the life of the Plan.
 10. The Plan is a highest level plan, for the purpose of identifying the community's vision for its future, as well as its main strategies for achieving them.
 11. The strategic planning process will consider the issues and pressures which may affect the community and the level of resources realistically available to achieve its aims and aspirations. Whilst Council has a custodial role in initiating, preparing and maintaining the Plan on behalf of the community, it is not wholly responsible for its implementation. Other partners, such as State agencies and community groups may also be engaged in delivering the long-term objectives of the Plan.
 12. Under the IPR guidelines a strategic community plan must involve engagement with community and minimum standards are outlined in the guidelines.

DETAILS

13. At its meeting in December 2015, Council endorsed the process to review the Kalamunda Advancing: Strategic Community Plan 2013 and to create the second version, namely Kalamunda Advancing: Strategic Community Plan to 2027.
14. A consultant was engaged to prepare documentation and to facilitate a series of workshops and to analyse the information and draft the Plan.
15. Discussion with community centred on four Priority Areas providing the framework for the delivery of services to the community. Each Priority Area provides overarching concepts which together articulate the scope the Shire will operate under. The Priority Areas are not independent of each other they are intrinsically interrelated and interdependent upon each other for success to be achieved. Each Priority Area is of equal importance.

-
16. The key critical shifts in the operating environment, since 2012, identified with implications across all Key Result Areas and include:
- a slowdown in the Western Australian economy
 - shifts in economic growth industries
 - population growth and residential development may be less than anticipated
 - increasing pressure to demonstrate responsiveness to environmental issues
 - changing role for local government in community service provision in a complex operating environment. (Increased and changing customer expectations, Federal and State funding arrangements and legislative changes)
 - increasing accountability and performance expectations from State Government and the community.

Feedback from community workshops and the surveys consistently reflected these shifts. Key areas of priority were supporting local business and local employment, improvements to infrastructure and accessible connectivity, increasing demand for community services and support from the Shire, all in balance with the preservation of Kalamunda's cherished natural environment.

17. The Plan responds to three questions put to the community and the local government:

- Where are we now?
- Where do we want to be?
- How do we get there?

18. It also prioritises community aspirations, giving consideration to:

- Social objectives.
- Economic objectives.
- Environmental objectives.
- Factors such as changing demographics and land use.
- Good governance of the district.

19. The engagement and consultation processes, which included workshops and surveys, have been used to clearly shape the vision and the aspirations of the Shire's community. The information gathered was compiled and a Strategic Community Plan Review - Consultation Feedback Report - October & November 2016 was published and circulated with the draft Plan during the public consultation period.

20. The review process concluded that four Priority Areas would form the basis of the revised Plan. Each Strategic Priority Area will provide the framework for the delivery of services to the community, providing overarching concepts that together articulate the scope from which the Shire will operate.
- Kalamunda Cares and Interacts
 - Kalamunda Develops
 - Kalamunda Clean and Green
 - Kalamunda Leads

Under each priority area high level objectives, strategies and measures have been developed.

STATUTORY AND LEGAL CONSIDERATIONS

21. All local governments are required to produce a Plan for the future under S5.56 (1) of the *Local Government Act 1995*.
- Detailed Guidelines were developed in 2016 made under S5.56 (2) of the Act to briefly outline the minimum requirements to achieve successful integrated planning.
22. Regulation 19C of the *Local Government (Administration) Regulations 1996* stipulates the details required to be included in the Strategic Community Plan.
- Regulation 19D of the *Local Government (Administration) Regulations 1996* requires that local public notice is given advising that the Plan has been adopted.

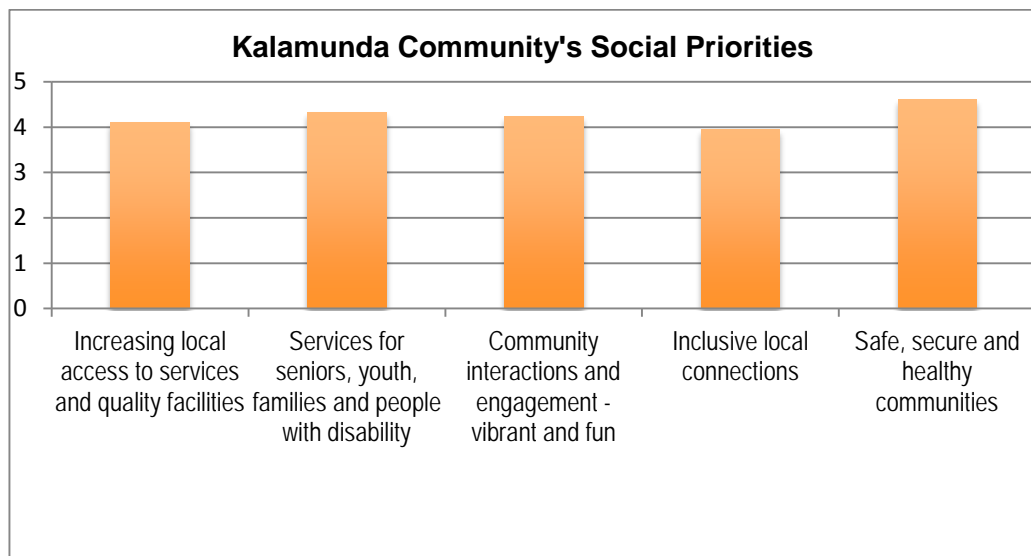

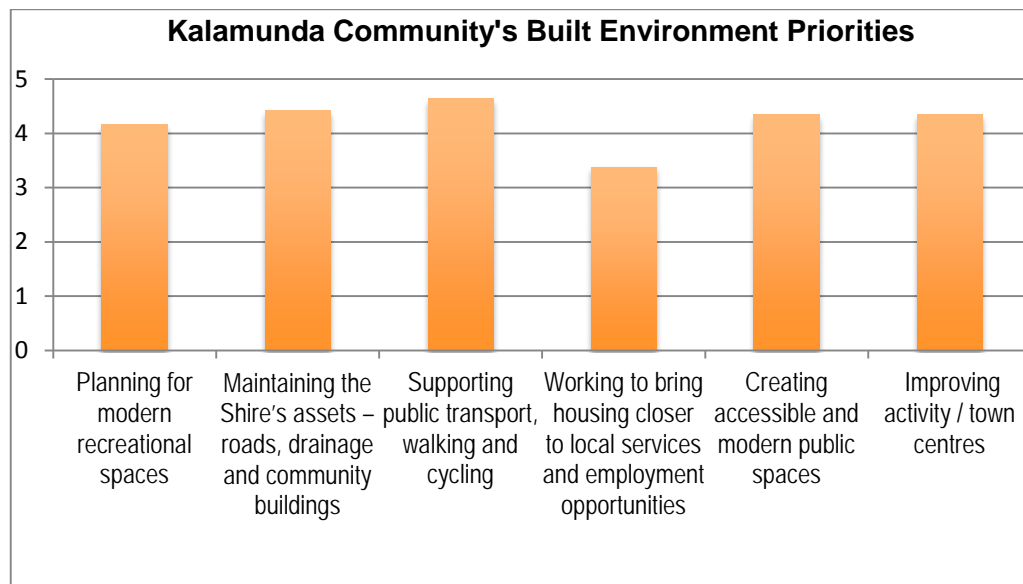

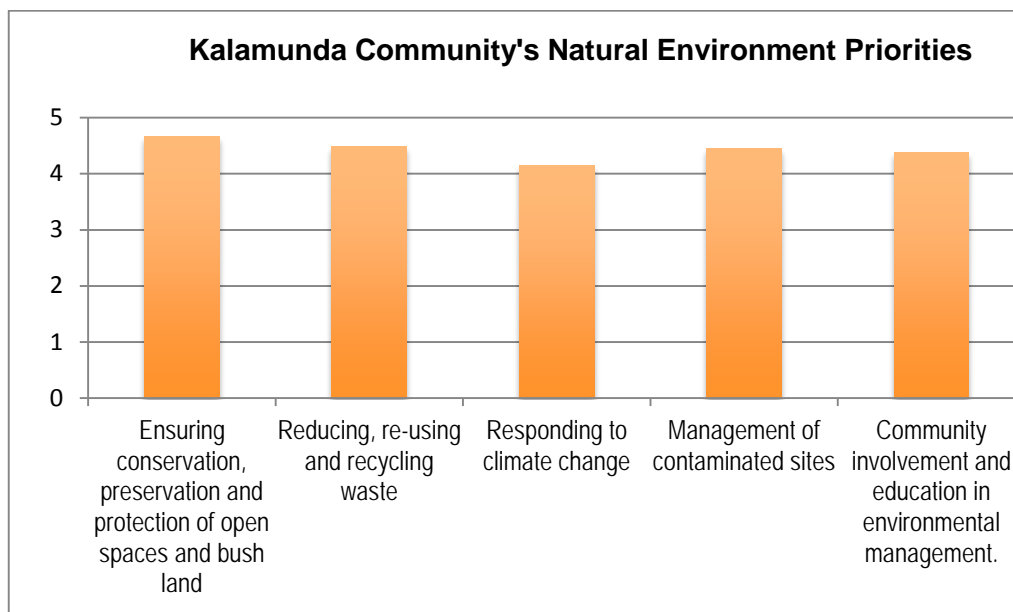

34. Whilst the feedback received in most instances was very useful for improving the Plan, it also revealed that many members of the community do not fully understand the high level overarching and conceptual intent of a strategic plan. More work needs to be done to educate the community about the Shire's Integrate Planning and Reporting Framework.
35. Commentary provided by the community on environmental issues gave particularly good feedback which has enabled the Plan to be strengthened in terms of sustainability.

EXECUTIVE SUMMARY

1. To consider adoption of Kalamunda Achieving – Corporate Business Plan 2017-2021.
2. Kalamunda Achieving - Corporate Business Plan 2017-2021 is part of the suite of plans required by the Integrated Planning and Reporting Framework.
3. This report recommends adoption of the Shire of Kalamunda's four year Corporate Business Plan, Kalamunda Achieving: Corporate Business Plan 2017 – 2021 shown at Attachment 1.

BACKGROUND

4. The Department of Local Government's (Department) Integrated Planning and Reporting Framework (IPR) requires local governments to establish a number of interlinked guiding plans. The outcomes of a successful integrated planning process, as stated by the Department, are:

"A Strategic Community Plan that clearly links the community's aspirations with the Council's vision and long term strategy;

A Corporate Business Plan that integrates resourcing plans and specific council plans with the Strategic Community Plan, and

A clearly stated vision for the future viability of the local government area."

5. In adopting *Kalamunda Advancing: Strategic Community Plan to 2027* (the Strategic Plan) the next element of the integrated planning framework, the Corporate Business Plan is now presented.

DETAILS

6. Based upon alignment with the Strategic Community Plan, Kalamunda Achieving: Corporate Business Plan 2017 -2021 (Attachment 1) ("Kalamunda Achieving") sets out the priority actions, services and projects timeframes and measures the Shire will carry out over a four year period. Kalamunda Achieving also outlines the resources required to deliver the Plan which are formulated through the Long Term Financial Plan and the Workforce Plan.

7. Kalamunda Achieving addresses the requirements of the Integrated Planning Framework. Each priority action, service or project within the Plan is linked to an Objective and Strategy from the adopted Strategic Plan. This ensures the operations of the Shire are leading towards the achievement of the community's vision for its future.
8. The resourcing of the operational priorities in *Kalamunda Achieving* is linked to the ten-year Long Term Financial Plan. The Financial Plan includes the projected operational costs and funding for the major projects which have been planned.
9. *Kalamunda Achieving* has been developed by taking into consideration the long term projections of the Workforce Plan (ensuring sufficient resources will be available to achieve the priority actions) and the major projects and infrastructure requirements of the Asset Management Plan. A number of other informing plans and strategies have also been referred to in developing the priority actions, for example, the Aged Accommodation Strategy and Youth Plan. This integrated planning approach will ensure the strategic direction of the Shire is translated into achievable and sustainable operational goals.
10. *Kalamunda Achieving* includes measures and targets by which the achievement of each priority action, service or project can be measured. The Quarterly Progress Report will enable Council to monitor the progress of the Corporate Business Plan actions on a regular basis. The Annual Report will also provide Council and the community with information on the achievement of these priorities.
11. The Shire's business planning and reporting tool, Interplan, will be used to ensure that there is accountability for the achievement of the priority actions, and that progress can be monitored and reported at any time.
12. The activities set out in *Kalamunda Achieving* are to be reviewed and re-prioritised on an annual basis. The review will be carried out in conjunction with the preparation of the annual budget. An additional year of actions will be added each year, and the current year's actions recorded as completed and archived. This will ensure that the focus of the Shire's operations is able to change in response to its community's needs or the availability of resources.

STATUTORY AND LEGAL CONSIDERATIONS

13. All local governments are required to produce a Plan for the Future under s5.56 (1) of the *Local Government Act 1995*. It is intended regulations will be made under s5.56 (2) of the Act to outline the minimum requirements to achieve this.
14. Regulation 19DA of the *Local Government (Administration) Regulations 1996* stipulates the details required to be included in the Corporate Business Plan.

POLICY CONSIDERATIONS

15. The Shire's Governance and Policy Framework calls for the development and regular review of the Corporate Business Plan.

COMMUNITY ENGAGEMENT REQUIREMENTS

Internal Referrals

16. All relevant service areas have provided input into the development of the Kalamunda Achieving: Corporate Business Plan shown at Attachment 1.

External Referrals

17. A Corporate Business Plan under the legislative framework is an operational document and is not required to be referred to external parties or for public comment.

FINANCIAL CONSIDERATIONS

18. The cost to undertake the review of Kalamunda Achieving: Corporate Business plan 2017/2021 was completed by in house resources.
19. The Shire's Long Term Financial Plan funds the Kalamunda Achieving. This is a ten year rolling plan which will link to the Corporate Business Plan and Strategic Community Plan priorities. It indicates the Shire's long term financial sustainability and allows early identification of financial issues and their longer term impacts.

- 25. Kalamunda Achieving - Corporate Business Plan will be implemented through the application of the Corporate Reporting Interplan system.
- 26. All actions outlined in the Corporate Business Plan will be transferred into the system and designated officers will be responsible for delivering the actions and preparing the progress report on a quarterly basis.
- 27. Council will determine which major actions and projects are reported through the **Quarterly Progress Report to the Community** and the Executive Management Team will receive progress on all other actions. The Quarterly Progress Reports will be used to monitor accountability, progress and the achievement of the targets that have been set in the Plan.
- 28. The Corporate Business Plan is essentially the Shire's corporate performance management and reporting mechanism. It allows for maximum transparency of the work that will be undertaken by the Shire's administration and enables the Community and the Council the ability to clearly track performance and delivery of the Community Strategic Plan.
- 29. The Corporate Business Plan enables the Shire to be proactive, plan approximately detailed work programs and maintain alignment with the objective of the Shire. It ensures that the organisation is working towards common goals shared by the Council and community and also enables resources to be allocated appropriately. Without a Corporate Business Plan the Shire would become reactive, less efficient and directionless.
- 30. The Corporate Business Plan will be reviewed each year in conjunction with the preparation of the annual budget. An additional year of actions will be added each year whilst the current year's actions are recorded as completed, carried forward if required or archived.

3.2 Corporate Business Plan

Description

Overview

The Corporate Business Plan (Corporate Business Plan) is the Council's 4-year planning document. It gives effect to the first four years of the Strategic Community Plan and is pivotal in ensuring that the medium term commitments are both strategically aligned and affordable. This is achieved through rigorous scrutiny and prioritisation in the Strategic Review process (see Section 5).

Key points

Again, it is helpful to articulate the key points of the Plan – what difference it will make to the community – in the front of the Plan. The key points of the Corporate Business Plan will tend to be highly tangible and specific.

Vision and strategic direction

The Corporate Business Plan typically includes a summary of strategic direction, including the ten and four-year priorities.

Assumptions and sensitivities

The assumptions for the coming years are included and significant sensitivities noted.

Who is responsible for what

The Plan also shows where functional responsibilities sit for external and corporate services. The organisation chart may be included if desired.

Services, service levels, any planned changes and major projects

The core of the document is the plan for the delivery of services, linked to strategic direction, over the four-year period. This should clearly show the service levels to be provided and any changes from current service levels. It should also identify major projects.

Financial profile and links to asset management plans and workforce plan

The service levels to be provided will have been prioritised based on an assessment of the costs and benefits of different options. By the time these have settled into the best balance between aspirations and affordability, the corresponding four-year financial forecasts will be able to set out the expected rating levels over the term of the Plan. Workforce and asset management implications and resourcing requirements will have been incorporated.

Risk management

Again, the risks to the Plan are identified and managed.

Monitoring and reporting

Finally, the progress and performance measures are included (see also Section 4). There is more emphasis on performance in this Plan. Note that the Corporate Business Plan is reviewed and updated every year.

EXECUTIVE SUMMARY

1. The Shire of Kalamunda adopted its first Community Engagement Strategy in March 2013 and has recently completed the four yearly review of the Strategy.
2. Following an external peer review it was agreed the Strategy would be restructured and more closely aligned to international best practice standard for public participation prescribed by AIP2.
3. This report recommends adoption of the Community Engagement Strategy - Kalamunda Engages Community Engagement Strategy 2017.

BACKGROUND

4. The *Local Government Act 1995* (the Act) contains a legislative requirement to ensure community input is a part of the decision making process and best practice recommends that Councils' should formally adopt a Community Engagement Strategy.
5. In 2010, the Integrated Planning and Reporting (IPR) Framework and Guidelines were introduced in Western Australia (WA) as part of the State Government's Local Government Reform Program. All local governments were required to have their first suite of IPR documents in place by 1 July 2013.
6. This Department for Local Government's (the Department) Integrated Planning and Reporting Framework is intended to meet the changes to the Act and guide local governments to a successful integrated strategic planning process. At its most simple, this will deliver the following outcomes:
 - A long term strategic plan that clearly links the community's aspirations with the Council's vision and long term strategy.
 - A corporate business plan that integrates resourcing plans and specific Council plans with the strategic plan.
 - A clearly stated vision for the future viability of the local government.
7. In 2016 the Department introduced guidelines that provide advisory standards for local government to aspire. In meeting the standards one requirement is the need to develop and adopt a Community Engagement Strategy.

DETAILS

8. The development of the Strategic Community Plan requires extensive engagement with the community. To facilitate the ongoing incorporation of community input into the Shire's planning priorities; the Shire developed and adopted a Community Engagement Strategy – Kalamunda Engages in 2013.
9. The aim of the Community Engagement Strategy is to support Shire staff in undertaking community engagement and to present a transparent process to the community outlining how the Shire will engage.
10. The Community Engagement Strategy has been reviewed and aligned to best practice principles articulated in IAP2 International Standard for Public Participation. The core value of the IAP2 Framework is to ensure people whose lives are effected by a decision have the right to be involved in some way in the decision-making process.
11. In particular this Strategy will:
 - Establish standard processes for community engagement
 - Ensure those processes are implemented by shire staff and where relevant by external consultants employed by the Shire
 - Ensure relevant decision making takes account of outcomes acquired from such processes along with relevant legislative requirements and other Council policies
 - Ensure the community is kept informed of decisions emanating from community engagement

STATUTORY AND LEGAL CONSIDERATIONS

12. All local governments are required to plan for the future of their district under Section 5.56 (1) of the Act. Regulations under Section 5.56(2) of the Act outline the minimum requirements to achieve this. The Department of Local Government Integrated Reporting and Planning Framework requires the development of a Community Engagement Strategy.

POLICY CONSIDERATIONS

13. A Communication and Engagement Policy is under development and will provide guiding principles for engagement by the Shire and will be presented for endorsement by the Council.

COMMUNITY ENGAGEMENT REQUIREMENTS

Internal Referrals

14. The Community Engagement Strategy will in turn facilitate effective community engagement. All relevant service areas have contribution to the development of the Community Engagement Strategy shown at Attachment 1.

External Referrals

15. The draft Kalamunda Engages – Community Engagement Strategy was referred to Aha Consulting for expert peer review.

FINANCIAL CONSIDERATIONS

16. The cost to undertake the review of Kalamunda Engages was completed by in house resources and peer reviewed for a cost of \$2,000.

EXECUTIVE SUMMARY

1. To provide an overview of the annual Australian Mayoral Aviation Council Conference.
2. AMAC Members were requested by Northern Midlands Council for AMAC to support approaching the Administrative Appeals Tribunal, and if that fails, for their support in a court case.
3. This report recommends Council note the report from the Australian Mayoral Aviation Council 2017 Annual Conference.

BACKGROUND

4. The Australian Mayoral Aviation Council (AMAC) was established in 1982 and has become the umbrella organisation representing the community views on aviation issues throughout Australia.

The role of AMAC is to manage matters of national significance or matters that need coordination by all Australian governments.
5. The Shire of Kalamunda is a representative Council on the Perth Airports Municipalities Group. The Group's local focus is to engage stakeholders in effective dialogue to raise mutual awareness of the impacts of airport operations and developments on the local community and vice versa and, where possible, seek acceptable outcomes which foster the co-existence of communities and airports.
6. The AMAC has advocated with government to become a recognised umbrella organisation representing community views on aviation issues throughout Australia. The organisation has established avenues for input into the legislative process, aviation policy development and operational requirements which have an effect on community well-being.

7. The AMAC Conference is designed to provide delegates with the opportunity to meet and discuss issues, to hear and examine speakers on a wide variety of subjects and to determine the future of the organisation through the forum of the Annual General Meeting.

DETAILS

8. The AMAC 2017 Annual Conference was held from 3 to 5 May 2017 at the Novotel Sydney Brighton Beach in Sydney.
9. A brief outline of the Conference is shown at Attachment 1 to the Report.
10. A key issue highlighted at the conference was in relation to the Rate Equivalent Payments issue being faced by the Northern Midlands Council in Tasmania whereby they continue to pursue the enforcement of the lease arrangements between Australian Pacific Airports Corporation and the Commonwealth for ex-gratia rates payments in excess on \$1.35m.

The failure of the Australian Pacific Airport Corporation (Launceston Airport) to contribute their fair share of ex-gratia rates, as determined by their lease with the Commonwealth and the Tasmanian State Valuer – General puts not only the Northern Midlands Council at risk from losing its rates equivalents revenue, it may create a precedent and flow on effect to all other Australian Airport operators.

The issue has been in dispute for several years and no resolution has yet been found. The Airport engaged a private Valuer to determine a rate equivalent and the Council has no say in this determination. The Department of Infrastructure and Regional Development continues to provide instructions to the “independent valuer” to ignore key areas of the airport, which by interpretation of the lease, should be included as rateable area pursuant to the lease.

Rateable areas are where a commercial income is derived, for example parts of a terminal building dedicated to check-in, security screening, departure lounges and arrival/baggage claim.

AMAC Members were requested by Northern Midlands Council for AMAC to support approaching the Administrative Appeals Tribunal, and if that fails, for their support in a court case.

At the C&C Services Committee meeting on 15 May 2017 I advised in response to a question that I would provide to Councillors costs associated with the purchase and storage of temporary fencing equivalent to that used at Alan Anderson Park.

Please find attached the quotes with summaries as follows:

1. TTFS Manufacture and supply of fencing components \$9738.32
2. JP Pallets Manufacture and Supply of Steel Pallets for storage and transport \$14,124.00 (based on \$2,354 per pallet and the need for 6 pallets)

Total estimated cost of temporary fencing and storage/transport pallets = \$23,862

It is also confirmed that the Shire has a stockpile of temporary fencing at the Operations Centre equivalent to a length of approx. 140metres. This has proved to be more than sufficient to accommodate the small type works undertaken by the Shire.
