**Associated Notes:** It may be of interest to you that during the course of circulating the petition we have been repeatedly told that traffic volumes have increased enormously around the Town Centre in recent time, including heavy vehicle trucks. The origin and destination of which seem to be very much more than local traffic, perhaps using Kalamunda as a short cut to and from the south to Midland etc.

We have also been told by a retired Roads Engineer that the ‘pseudo’ vehicle priority walkways’ around the Town Centre are highly dangerous, being repeatedly misunderstood by both drivers and pedestrians as well as visitors to Kalamunda; and do not comply with Australian standards and in-particular being far too close to road junctions. As a result many rear-end accidents have been witnessed particularly at the Junction of Haynes St and Canning Road, as well as fatalities – one at the junction of Haynes and Railway Road and another at the junction of Heath Road and Canning Road.

However, our primary concern as stated in this Petition is for the substantial numbers of residents with various disabilities and infirmities that are limited to shopping and socialising in the Kalamunda Town Centre, but in order to do so are obliged to take unreasonable risks, that should be avoidable, given reasonable provision by the City of Kalamunda.
