We, the undersigned, all being electors of the City of Kalamunda do respectfully request that the Council— set up a meeting before 21 May 2026 with the Government, CEO City of Kalamunda, a Ratepayer representative from each Ward and two landowners from High Wycombe South. The purpose of the Petition is for all Ratepayers of the City of Kalamunda and individual Landowners in High Wycombe South, to receive a competent reply to claims resulting from the process to change the zoning for only a segment of sterilised land, namely Stage 3 of the Kewdale Hazelmere Integrated Masterplan Forrestfield Precinct.

The whole of the area of the KHIM Forrestfield Precinct was sterilised by the Government as industrial land use only. About 8 years later, Stage 3 area was rezoned residential to be pivotal in the ROI economic evaluation to secure \$490 million of Federal funding for the Forrestfield Airport Link. About 1/3rd of Stage 3 was later taken as the TOD precinct. The remaining 2/3^{rds} of the land in Stage 3 has suffered massive losses. Ratepayers incurred a loss estimated at \$50 million on current land valuations because the 9.6 hectare landfill site cannot be sold for industrial land use. Now a park.
