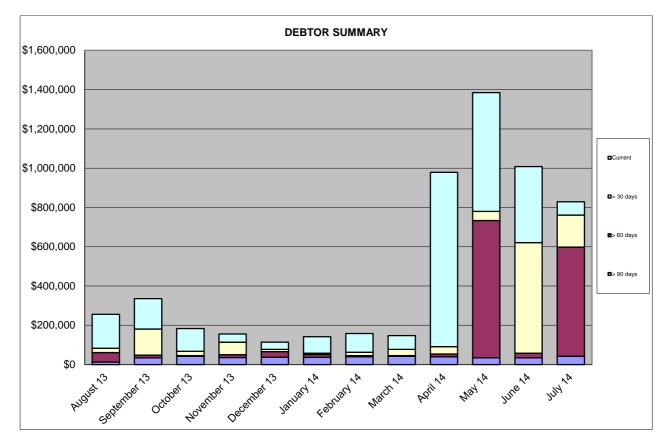

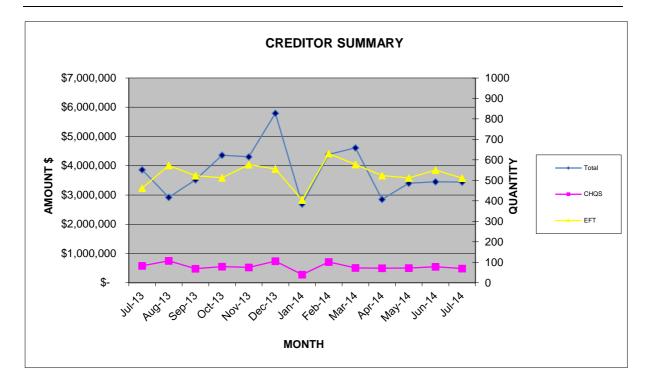

PURPOSE

1. To receive a report on rates debtors for the period ended 31 July 2014.

BACKGROUND

- 2. Attached is the report detailing rates debtors for the period ended 31 July 2014 (Attachment 1).
- 3. Rates notices were issued on 10 July 2014

Instalment dates are as follows: Option 1 (Full Payment) - By 14 August 2014

Option 2 (Two Instalments) –	1 st Instalment Date by 14 August 2014 2 nd Instalment Date by 18 December 2014
Option 3 (Four Instalments) –	1 st Instalment Date by 14 August 2014 2 nd Instalment Date by 16 October 2014 3 rd Instalment Date by 18 December 2014 4 th Instalment Date by 12 February 2015

A grace period of two weeks is given before closing the instalment period. Any amounts outstanding on those ratepayers with an instalment option are regarded as defaulted and essentially fall off from this arrangement.

The Shire can accept a direct debit payment arrangement to finalise the balance or a special payment arrangement is made in extenuating circumstances. Strict protocols are maintained so that the Shire is seen to be fair and equitable to all ratepayers.

4. As noted on (Attachment 1), the Shire has collected \$4,072,388 (includes Deferred Balance of \$463,579) or 14% of the debt from the date the rates and service charges were raised.

5. No Interim rates have been raised since May 2014 these will commence after the first instalment date of 14 August 2014 has passed.

DETAILS

6.

Debt Recovery

- There are 11 outstanding debts from 2012/13 that remain with Dun & Bradstreet (D&B) that have had Judgement entered against them; All have been issued with "Property Sales and Seizure Order" (PSSO) the next step is to proceed with Land Warrants for these properties which will occur in 2014/2015.
 - There remains 33 Ratepayers from 2013/2014 who have not responded to judgement and no payment has been received. Judgement has been awarded against these properties where a PSSO has been issued.
 - A report will be brought to Council in 2014/2015 to approve the issuance of a land warrants for those that have proceeded to Judgment and have still not satisfied the claim.
 - 87 ratepayers have direct debits in place for outstanding rates.

STATUTORY AND LEGAL CONSIDERATIONS

7. The Shire collects its rates debts in accordance with the *Local Government* Act (1995) Division 6 – Rates and Service Charges under the requirements of subdivision 5 – Recovery of unpaid rates and service charges.

PURPOSE

1. To receive the Community Care Quarterly Report – June 2014

BACKGROUND

2. The quarterly report is prepared in accordance with the approved Kalamunda Home and Community Care (KHACC) Business Case (2010 – 2014). The basis of which is:

> "That the Home and Community Care Services provided, be within the limits of funding available and reviewed every quarter and reported to Council."

DETAILS

- 3. Referrals for Home and Community Care (HACC) support are received from the Regional Assessment Service. Community Care do not screen for eligibility nor assess potential clients for services and as such, we are dependent on these referrals to maintain and increase service levels.
- 4. Inception of the Assessment Framework in 2011 has resulted in increased compliance with eligibility criteria and people receiving services based on assessed need and not just an eligibility status, meaning a person with an ongoing functional disability may be eligible for HACC support but with the provision of the correct assistive equipment may continue to support themselves independently without formalised support.

HACC SERVICE DELIVERY

- 5. The Volumes Report (Attachment 1) shows how Community Care is performing in relation to its contracted service provision levels for the HACC program.
- 6. The HACC Contract contains service groups that cluster, where appropriate, like service types together. Service Group 1 includes the following service types: domestic assistance, personal care, social support, respite and other food services.

- 7. Service Group 1 was contracted to provide hours of support against the service types listed in paragraph 6. This allows the service types to be adjusted to meet the needs of eligible clients regardless of the contracted number of hours against each service type.
- 8. Because of this service grouping, a service type such as domestic assistance can achieve higher than 100% of service delivery, providing other service types are not also achieving 100%. The hours are used in a flexible manner to address need.
- 9. During this quarter Community Care was contracted to provide 6231 hours across service group 1 to eligible community members. 4177 hours were provided (67%). This is a 7% increase from last quarter.
- 10. For the 2013/2014 financial year Community Care was contracted to provide 24,931 hours across service group 1 to eligible community members. 15,125 hours were provided (61%). This is a 2% increase from last year.

Domestic Assistance (Service Group 1)

- 11. During this quarter Community Care was contracted to provide 2874 hours to eligible community members. 2999 hours were provided (104%). This is an 11% increase from last quarter.
- 12. Impacts on these hours included 381.25 hours that were not provided due to public holidays and clients cancelling services to attend to other commitments, illness or being hospitalised. Had these hours been provided Domestic Assistance would have achieved 118%, which would have been accommodated by the flexible delivery model assigned to Service Group 1 as detailed in paragraph 7.
- 13. For the 2013/2014 financial year Community Care was contracted to provide 10,973 hours of Domestic Assistance to eligible community members. 10,974 hours were provided (95%). This is a 4% increase from last year.

In Home Respite (Service Group 1)

- 14. During this quarter Community Care was contracted to provide 450 hours to eligible community members. 99 hours were provided (22%). This is a 3% increase from last quarter.
- 15. For the 2013/2014 financial year Community Care was contracted to provide 1800 hours of In Home Respite to eligible community members. 280 hours were provided (16%). This is an 8% increase from last year.

Other Food Services (Service Group 1)

16. During this quarter Community Care was contracted to provide 96 hours to eligible community members. 21 hours were provided (22%). This is a 2% decrease from last quarter.

- 17. Impacts on these hours included 1.75 hours that were not provided due to public holidays and clients cancelling services to attend to other commitments, illness or being hospitalised. Had these hours been provided Other Food Services would have achieved 24%.
- 18. For the 2013/2014 financial year Community Care was contracted to provide 386 hours of Other Food Services to eligible community members. 79 hours were provided (20%). This is a 10% increase from last year.

Social Support (Service Group 1)

- 19. During this quarter Community Care was contracted to provide 1875 hours to eligible community members. 765 hours were provided (40%). This is a 5% increase from last quarter.
- 20. Impacts on these hours included 195.75 hours that were not provided due to public holidays and clients cancelling services to attend to other commitments, illness or being hospitalised. Had these hours been provided Social Support would have achieved 51%.
- 21. For the 2013/2014 financial year Community Care was contracted to provide 7500 hours of Social Support to eligible community members. 2687 hours were provided (36%). This is a 3% decrease from last year.

Personal Care (Service Group 1)

- 22. During this quarter Community Care was contracted to provide 936 hours to eligible community members. 293 hours were provided (31%). This is a 3% decrease from last quarter.
- 23. Impacts on these hours included 63.25 hours that were not provided due to public holidays and clients cancelling services to attend to other commitments, illness or being hospitalised. Had these hours been provided Personal Care would have achieved 38% which would have been a 4% increase on the last quarter.
- 24. For the 2013/2014 financial year Community Care was contracted to provide 3784 hours of Personal Care to eligible community members. 1106 hours were provided (29%). This is a 6% decrease from last year.

Centre Based Day Care (Service Group 4)

- 25. During this quarter Community Care was contracted to provide 9978 hours to eligible community members. 7716 hours were provided (77%). This is equal with last quarter.
- 26. Impacts on these hours included 1206 hours that were not provided due to public holidays and clients cancelling services to attend to other commitments, illness or being hospitalised. Had these hours been provided Centre Based Day Care would have achieved 89% which would have been a 12% increase from the last quarter.

27. For the 2013/2014 financial year Community Care was contracted to provide 39,917 hours of Centre Based Day Care to eligible community members.
29,986 hours were provided (75%). This is a 2% decrease from last year.

Meals on Wheels (Service Group 6)

- 28. During this quarter Community Care was contracted to provide 2445 meals to eligible community members. 1466 meals were provided (60%). This is a 15% increase from last quarter.
- 29. Impacts on these hours included 107 meals that were not provided due to public holidays and clients cancelling services to attend to other commitments, illness or being hospitalised. Had these hours been provided Meals on Wheels would have achieved 64%.
- 30. For the 2013/2014 financial year Community Care was contracted to provide 9778 meals to eligible community members. 4925 hours were provided (50%). This is a 7% increase from last year.

Transport (Service Group 7)

- 31. During this quarter Community Care was contracted to provide 6816 one way trips to eligible community members. 3893 one way trips were provided (57%). This is a 3% increase from last quarter.
- 32. Impacts on these hours included 1467 one way trips that were not provided due to public holidays and clients cancelling services to attend to other commitments, illness or being hospitalised. Had these hours been provided Transport would have achieved 78%.
- 33. For the 2013/2014 financial year Community Care was contracted to provide 27,267 one way trips to eligible community members. 14,906 trips were provided (55%). This is a 1% increase from last year.

Client Support Information and Advocacy (Service Group 9)

- 34. During this quarter Community Care was contracted to provide 645 hours to eligible community members. 286 hours were provided (44%). This is a 3% increase from last quarter.
- 35. For the 2013/2014 financial year Community Care was contracted to provide 2574 hours of Client Support Information and Advocacy to eligible community members. 1128 hours were provided (44%). This is a 15% increase from last year.

Home Maintenance (Service Group 10)

36. During this quarter Community Care was contracted to provide 1791 hours to eligible community members. 1421 hours were provided (79%). This is a 10% increase from last quarter.

- 37. Impacts on these hours included 355.5 hours that were not provided due to public holidays and clients cancelling services to attend to other commitments, illness or being hospitalised. Had these hours been provided Home Maintenance would have achieved 99%.
- 38. For the 2013/2014 financial year Community Care was contracted to provide 7166 hours of Home Maintenance to eligible community members. 5170 hours were provided (72%). This is a 2% decrease from last year.

COMMUNITY VISITORS SCHEME

- 39. During this quarter Community Care was contracted to provide 270 to eligible community members. 192 visits were provided (71%).
- 40. Impacts on these hours included 104 visits that were not provided due to volunteer availability. Had these visits been provided the Community Visitors Scheme would have achieved 109%.

COMMUNITY AGED CARE PACKAGES (CACP)

- 41. During this quarter Community Care was contracted to provide 20 packages to eligible community members. 13 packages were provided (65%).
- 42. Referrals for packages come from the Aged Care Assessment Team (ACAT). Community Care do not screen for eligibility nor assess potential clients for services and as such, we are dependent on these referrals to maintain and increase service levels.
- 43. CACP are being transitioned to Consumer Directed Care Packages as of 1 July 2015. Community Care are preparing an implementation plan to drive this program, procedural and cultural change.

- 53. During this quarter Community Care had 35 clients exit the HACC program. The feedback from clients and/or family as to why the services were ceasing were
 - The client has moved to a higher level of community care support or residential care eight responses
 - The client is now self-managing 10 responses
 - The client has passed away 11 responses
 - The client didn't commence services two responses
 - The client has relocated out of the service area two responses
 - Services didn't meet the client's expectations two responses
- 54. In most services, there are adequate numbers of clients to achieve approximately 80% or more volume, however there is always a variance in what is scheduled to be delivered and what is actually delivered.
- 55. The 2013/2014 financial year has seen improvement and growth in most HACC service groups. Having improved staffing levels has meant that no services needed to be closed for referrals, allowing services to remain stable and grow in most instances.
- 56. Community Care did not apply for growth funding from HACC for 2014/2015. Community Care provided two business cases to modify services within the existing Services Schedule to implement new service models.
- 57. Community Care applied for an increase of Home Care Packages Level 2 from the Department of Social Services (formally) Department of Health and Ageing.
- 58. Community Care staff participated in a process of identifying and selecting values that underpinned the purpose of Community Care services. This information will be used to drive the implementation of Consumer Directed Care.

PURPOSE

1. To report to Council on the Shire's progress towards achieving its strategic goals.

BACKGROUND

- 2. The Quarterly Progress Report is generated from the Shire's integrated planning system, "interplan". The report reflects the progress of individual actions, which are linked to the adopted Strategic Plan. This ensures that each employee is working towards achieving the strategic direction of the Council.
- 3. The person responsible for an action or task in interplan is required to provide an update each month, giving an indication of how the action is progressing. Key Performance Indicators (KPIs) are also updated. This information is collated by interplan to provide an overview of how the organisation is performing.

DETAILS

- 4. The Quarterly Progress Report for the period 1 April 2014 to 30 June 2014 is presented at (Attachment 1).
- 5. The report shows the progress of the actions and Key Performance Indicators for 2013/2014 from the Corporate Business Plan, *Kalamunda Achieving.* The report also shows the progress of the Shire against the goals set out in Council's Strategic Plan to 2023, *Kalamunda Advancing*.

Quarterly Progress Against Goals

6. Each business unit in the Shire has a business plan, which contains the actions to be achieved in the 2013/2014 year. Each of these actions is linked to a strategy, outcome and goal in the Strategic Plan adopted by Council.

- Of the 543 actions monitored across the organisation, 378 (or 70%) are at 90% or more of their progress target for the year to date. 112 actions (21%) are at less than 70% of their progress target. This has not changed since last quarter. The majority of these relate to Strategic Goal 6 "Kalamunda Leads Providing Good Government", and are operational in nature.
- 8. There will be an increased focus in the coming year on accountability. Managers will ensure that their staff regularly update their interplan actions, as "off-track" actions affect the reporting of the performance of the organisation as a whole. KPIs relating to the progress status of actions have been established, and will be monitored monthly.

Key Performance Indicators

- 9. Performance against the Shire's corporate KPIs is shown. At this stage, a number of the annual KPIs have not been updated. These measures have been derived from the Shire's Strategic Plan, to be reported to Council and the community.
- 10. Of the remaining 16 KPIs, for the period 1 July 2013 30 June 2014
 - Six are at or exceeding their target.
 - Six are within 10% of their target.
 - Four are below 10% of their target.
- 11. Two of the "off-track" KPIs relate to the determination of planning and subdivision applications. Such applications often require referral to other agencies, or to Council. This can lead to unavoidable delays. The other off-track KPI is derived from the employee satisfaction survey, and relates to staff satisfaction with the Shire's leadership and direction. Performance against this measure has actually improved since 2012/2013, it may be that the target is unrealistic.
- 12. Responding on time to Councillor requests dropped from 100% last quarter to 78% this quarter. Responding to incoming correspondence on time dropped from 91% to 81%. However, there was an improvement in response to customer requests, increasing from 78% on time to 85% this quarter.
- 13. Please note that the "traffic light" indicator on the Report only relates to the month of June 2014, not to the whole quarter.

Major Projects

14. The Corporate Business Plan, *Kalamunda Achieving*, set out a number of Priority Actions for the Shire for the four-year period to 30 June 2017. The progress of the Priority Actions for 2013/2014 is shown in the Major Projects section of the Report. The majority of actions are on track, or are being monitored (are between 40% and 90% of the progress target for the year to date, indicated by a yellow traffic light). 15. Some actions which are off-track (indicated by a red traffic light) have been delayed due to the uncertainty resulting from the local government reform process. Comments indicating the status of all actions and their current progress are included in pages 7 to 68 of the report.

PURPOSE

1. To consider supporting one external application for funding through the Department of Sport and Recreation's (DSR) Community Sport and Recreation Facilities Small Grant Fund (CSRFF).

BACKGROUND

- 2. Through the CSRFF program, the State Government provides financial assistance to community groups and Local Government Authorities to develop basic infrastructure for sport and recreation. The program aims to increase participation in sport and recreation with an emphasis on increasing physical activity through the provision of well-planned facilities.
- 3. The Shire's role in the provision of the funding is to call for applications and assess them in priority order, and rate each application received (Attachment 1).
- 4. The maximum grant approved will be no greater than one third of the total estimated project cost.
- 5. There is no obligation on the Local Government Authority to make any contribution to a project.
- 6. All applications for this small grants round are to be received by the Department of Sport and Recreation by 31 August for assessment.
- 7. Successful applicants will be advised in October 2014, with funds to be expended by 30 June 2015.

DETAILS

8. The Shire of Kalamunda has received one external application for the Department of Sport and Recreation's CSRFF 2014/15 Small Grants funding program.

9. Forrestfield Tennis Club

The Forrestfield Tennis Club have requested financial assistance and will be submitting a funding application for six flood light poles to be installed on the remaining two unlit tennis courts (Courts 5 and 6). The Club currently has 50 members.

- 10. The new lighting on the remaining courts will allow the Club to hold additional night games and will also cater for further casual users at night which has the potential to increase income for the Club.
- 11. With floodlighting on all courts available, competition, coaching and public use will be able to occur simultaneously.
- 12. The proposed cost contribution is as follows:

23. Through the CSRFF program, the State Government provides financial assistance to community groups and Local Government Authorities to develop basic infrastructure for sport and recreation. The program aims to increase participation in sport and recreation with an emphasis on increasing physical activity through the provision of well-planned facilities.

DISPUTE RESOLUTION:

- 1. **Primary Dispute Resolution** If a dispute arises between any of the parties in relation to interpretation of the Agreement, the dispute shall be determined by the following process:
 - a) The dispute shall be referred as soon as practicable to a joint meeting involving up to 2 authorised Club representatives and Officers of the Shire of Kalamunda
 - b) Should resolution not be achieved within sixty (60) days of the reference to the joint meeting under Clause a):
 - This agreement may be terminated by either party and any amounts owing under this Agreement to any party, will be paid within twenty one (21) days of the termination of this Agreement
 - The matter may be mutually referred to arbitration

2. Arbitration

The rights or obligations of either party hereunder or in respect of any matter which by the provisions of the Agreement is to be referred to arbitration shall be referred to a single arbitrator under and in accordance with the provisions of the Commercial Arbitration Act 1985.

If the parties are unable to agree upon the arbitrator, an arbitrator shall be appointment by the President of the Law Society of Western Australia for the time being, whose appointment is final.

PURPOSE

1. To consider a request from Kalamunda Community Radio for a proposed lease in principle over the site portion of Reserve 26843 at 36 Collins Road, Kalamunda.

BACKGROUND

- 2. Kalamunda Community Radio is a member based volunteer run, non-profit, community radio station which broadcasts a diverse range of music, in addition to being a communication tool for the community.
- 3. Kalamunda Community Radio's current site on the corner of Mead Street and Central Road in Kalamunda is owned by the State Government (WA Police) and is now on the market for sale.
- 4. Given the pending sale of Kalamunda Community Radio's current site, a new premise is required to house their operations.

DETAILS

- 5. With respect to Kalamunda Community Radio's current circumstances a range of different site options for a new home have been investigated and considered.
- 6. Sites considered have included Headingley Cottage, Jack Healey Centre, Sanderson Road and the Stirk Overflow Cottage. All were deemed unsuitable due to factors such as limited altitude to that of what is required for a radio broadcasting tower, conflicting user groups and/or location within a residential area.
- 7. The site at 36 Collins Road Kalamunda was put forward as an initial refurbishment option by Kalamunda Community Radio.
- 8. Upon inspection, the deteriorated building located at 36 Collins Road Kalamunda was deemed to be beyond repair and is consequently scheduled to be demolished and removed by the end of 2014.

- 9. Following demolition, there has been no alternative use identified for the 36 Collins Road Kalamunda site.
- 10. Subject to Kalamunda Community Radio's ability to seek and acquire external funding assistance through Lotterywest and other sources, 36 Collins Road Kalamunda has been identified as a suitable site to build a fit for purpose building.
- 11. The Reserve 26843 is currently listed for the purpose of "Recreation" and permission will need to be sought to the lease and to change the purpose of the Reserve to "Recreation and Community" purposes from the Minister for Lands.
- 12. Kalamunda Community Radio might also need to consider the prospect of a multi-functional, shared community group facility at the site with a service club for example which is likely to be viewed more favourably with potential funding sources.
- 13. For both funding provider requirements and for Kalamunda Community Radio's requirements a minimum of a five year lease over the site with a further five year option would be sought.
- 14. Acknowledging the need for Kalamunda Community Radio to acquire external funding support to build, in principle support is initially sought from Council to build on and lease the 36 Collins Road Kalamunda site.
- 15. Pending in principle support, the Shire will look to provide support in terms of the prospect of internal surveying of the site to assist Kalamunda Community Radio with the development of plans.

STATUTORY AND LEGAL CONSIDERATIONS

- 16. The site portion of Reserve 26843 at 36 Collins Road, Kalamunda is zoned for "Public Purpose", which essentially means it's a Local Reserve under the Local Planning Scheme and an application for a radio station can be considered.
- 17. As is the case with any development with planning approval a new building at the site will be required to comply with the Building Code of Australia.

POLICY CONSIDERATIONS

18. Lease Policy LEA1.

COMMUNITY ENGAGEMENT REQUIREMENTS

- 19. Given the proposed communication (broadcasting) tower that is required to be located to the site, community consultation may require consideration with businesses and/or residents within close proximity.
- 20. There is an existing telecommunications tower located in close proximity which may also require engagement with the owner to establish if there would be any implications with another located nearby.

FINANCIAL CONSIDERATIONS

- 21. Kalamunda Community Radio have already been informed of the requirement to seek external funding support (e.g. Lotterywest, Bendigo Bank) to develop and build on the 36 Collins Road Kalamunda site.
- 22. Under the provisions of the lease policy, should Kalamunda Community Radio build and lease the site, the operating costs of the lease and minor maintenance will be the responsibility of the lessee.
- 23. Major maintenance on the core building structure only (i.e. not communication tower) will be the responsibility of the Shire.

OFFICER COMMENT

- 29. Following demolition of the existing, deteriorated building, the subject site will become vacant for development.
- 30. Under the Shire's Local Planning Scheme, the site is zoned for "Public Purpose" for which a community radio station development can be considered.
- 31. The proposed development will be subject to Kalamunda Community Radio attracting sufficient external funding will enable the station to continue to provide a positive communication service to the community.
- 32. Consideration to the proposed development's design involving an additional community group to co-locate is likely to add weight to funding submissions.
- 33. It is recommended that in principle support is provided for the proposed development and lease of the 36 Collins Road, Kalamunda site.
- 34. If supported by Council, Kalamunda Community Radio will need to undertake some surveying and the Shire might consider providing as 'in kind' support.

PURPOSE

To consider a proposal from Rise to lease the commercial kitchen, scullery and 1. dining room at the Jack Healey Centre for a three year period with a three year option.

BACKGROUND

- Rise was established in July 1983 as an incorporated not for profit 2. organisation located within the East Metropolitan Region of Perth. For the past 30 years, Rise has worked with a number of State, Federal and Local Government organisations to deliver community services to more than 2,000 people within the wider Hills region. Their head office is located in Middle Swan and services are provided throughout the Shires of Kalamunda, Mundaring and the City of Swan. Rise has grown to a mission driven organisation with more than 400 staff and 50 volunteers providing support to over 2,000 people in the greater east metropolitan region.
- Rise's vision is to build on the capacity within each individual to achieve their 3. personal potential and they are committed to providing proactive, highly personalised solutions that deliver support to elderly members of our community, people with disabilities, and those with mental health issues, youth at risk and care givers.

DETAILS

4. The Jack Healey Centre is currently under-utilised particularly the kitchen, scullery and dining room areas. The proposal from Rise is to lease the abovementioned area from the Shire under a community lease arrangement so that they can establish a Community Kitchen which will offer cooking classes, and enable a group of like-minded individuals an opportunity to come together on a regular basis to socialise and cook affordable and nutritious meals.

> Community Kitchen participants have reported experiencing positive changes in:

- Social skills communication and interpersonal skills
- Teamwork and leadership skills working with others, taking a • leadership role
- Budgeting improved management of personal finances

- Cooking learning new recipes and cooking techniques
- Shopping saving money on food costs
- Improved motivation to cook at home and reduced intake of takeaway and fast food
- Access to food increased availability of food, and increased variety
- Literacy and numeracy
- Confidence and self esteem.
- 5. The Jack Healey Centre is currently used by other groups, such as Kalamunda Probus Club, Kalamunda Stamp Club, Kalamunda Districts Arts and Crafts, Alcoholics Anonymous and Alzheimer's Australia. Classes are also held for seniors including dance, fitness and computer courses. Refer (Attachment 2).
- 6. Rise are committed to working with the Shire and it residents as well as other users of the Jack Healey Centre so as not to adversely impact on the activities of other users of the Jack Healey Centre.
- 7. The Jack Healey Centre is considered a good fit for the needs of Rise. The kitchen and associated facilities offer good access to people with disability, the facility is fit for purpose and does not require the allocation of any additional Shire funding and the facility is currently under-utilised.
- 8. Rise proposes to utilise the facility under a community lease agreement for a three year period with a three year option. In line with the Lease Policy (C-PP02 *Community Group Leases)* Rise will be responsible for the day-to day costs associated with the buildings and any minor maintenance works. They will also be responsible for repairing any damage caused due to an act, omission of any member or visitor to their premises.

- 18. The proposal by Rise to lease the Kitchen facility at the Jack Healey Centre provides community benefits that will provide support to elderly members of our community, people with disabilities, and those with mental health issues, youth at risk and care givers. The Community Kitchen which will offer cooking classes, and enable a group of like-minded individuals an opportunity to come together on a regular basis to socialise and cook affordable and nutritious meals.
- 19. Under the proposed Community Lease Agreement, the Shire will bear no financial risk as the User Group will remain responsible for maintaining the Shire asset to a suitable standard, incurring costs for minor maintenance and outgoings. Rise will also work collaboratively with other users of the Jack Healey Centre.
