1.

To receive the report on rates debtors for the period ended 31 August 2015 (Attachment 1).

BACKGROUND

2. Rates notices were issued on 13 July 2015 with the following payment options:-

3. Rates Levied for the 2015/2016 Financial Year totalled \$31,884,691. Of this amount, approximately \$16.2m has been collected as at 31 August 2015. A total of 22,834 rate notices were sent on 13 July 2015. The rates department launched three additional services to better assist ratepayers in paying their amounts due. These are:

- "A smarter way to pay" allows the ratepayer to pay in small instalments over a 12 month period via direct debit. The model calculates a figure which ensures that the ratepayer will be in credit for the following year's rates. To date 346 ratepayers have signed up for the various direct debit option on offer of which 231 have elected the smarter way to pay.
- "eRates" allows the ratepayer to receive their future rates notices by email instead of the post. This will improve efficiency, is traceable and the ratepayer can be anywhere in the world and still receive their rates notice. It will also save the Shire >\$1 for every notice sent via email and not the post. To promote this service, one of the rates prizes traditionally offered was converted to purchasing apple and android tablets to obtain a better outcome. To date 996 properties have registered for electronic delivery. As Australia Post is set to increase postal charges by 40% from current rates, the more mail the Shire can send electronically will reduce our postal outgoings. The Shire has already recovered its set up fees and will be cash positive going forward.1

- "Bpay View" Allows the ratepayer to link the rates notice to their banking institution. This is an additional service that has been provided at no cost to the Shire by Commonwealth Bank of Australia (CBA). To date 119 people have signed up.
- 4. A total of 8,934 ratepayers have taken up an instalment option so far. Of these, 1,583 have taken up the option to pay by two instalments and 7,351 to pay by four instalments. A total of 12,457 ratepayers have paid in full. The due date for taking up the instalment options was 17 August 2015.
- 5. As noted on (Attachment 1), the Shire has collected \$16,233,863, or 50.37% of the debt from the date the rates and service charges were raised, compared to 50.17% at the same period last year.
- 6. The raising of Interim Rates for the 2015/2016 financial year will commence after the first instalment close date of 27 August 2015.

DETAILS

7.

Debt Recovery

- From 2012/2013 to 2013/2014 there are now nine claims outstanding with five claims waiting for a Property Seizure and Sales Order (PSSO) Land. These five properties have had rates outstanding for three years and over and all legal attempts to collect the rates has been unsuccessful. A briefing session was provided to Council on 25 May 2015. These five properties are now being passed on to the Shire's legal representatives for processing.
 - The Shire has issued 246 General Procedure Claims through the Courts for 2014/15 rates and service charges outstanding. Of these 246, the Shire has an active default judgement on 32 properties of which two are being defended. A total of 214 of these matters have been closed due to payment being received.
 - Of the 37 properties where the Shire has default judgement active, a total of 27 properties have had a Property Seizure and Sales Order (PSSO) Goods, issued or are awaiting issue through the Courts.
 - Debt recovery for 2015/16 commenced on 11 September 2015. Final Notices were sent to all properties with an outstanding balance of more than \$50.

8. The Shire collects its rates debts in accordance with the *Local Government Act (1995) Division 6 – Rates and Service Charges under the requirements of subdivision 5 – Recovery of unpaid rates and service charges.*

PURPOSE

1. To endorse the Community Care Quarterly Report – June 2015.

BACKGROUND

2. The quarterly report is prepared in accordance with Kalamunda Achieving: Corporate Business Plan 2015-2018. The basis of which is *"Produce a quarterly progress report for Community Care services".*

DETAILS

- 3. Referrals for Home and Community Care (HACC) support are received from the Regional Assessment Service. Community Care do not screen for eligibility nor assess potential consumers for services and as such, are dependent on these referrals to maintain and increase service levels.
- 4. Inception of the Assessment Framework in 2011 has resulted in increased compliance with eligibility criteria and people receiving services based on assessed need and not just an eligibility status, meaning a person with an ongoing functional disability may be eligible for HACC support but with the provision of the correct assistive equipment may continue to support themselves independently without formalised support.

HACC SERVICE DELIVERY

- 5. The Volumes Report (Attachment 1) shows how Community Care is performing in relation to its contracted service provision levels for the HACC program for the period of April, May and June 2015.
- 6. The HACC Contract contains service groups that cluster, where appropriate, like service types together. Service Group 1 includes the following service types: domestic assistance, personal care, social support, respite and other food services.
- 7. Service Group 1 was contracted to provide hours of support against the service types listed in paragraph 6. This allows the service types to be adjusted to meet the needs of eligible consumers regardless of the contracted number of hours against each service type.

- 8. Because of this service grouping, a service type such as domestic assistance can achieve higher than 100% of service delivery, providing other service types are not also achieving 100%. The hours are used in a flexible manner to address need.
- 9. During this quarter Community Care was contracted to provide 6285 hours across Service Group 1 to eligible community members. A total of 4299 hours were provided (68.5%). This is a 0.5% decrease from last quarter.
- 10. During the course of 2014/2015 Community Care was contracted to provide a total of 25,144 hours across Service Group 1 to eligible community members. A total of 17,788 hours were provided (71%). This is an 11% increase from 2013/2014.

Domestic Assistance (Service Group 1)

- 11. During this quarter Community Care was contracted to provide 2928 hours to eligible community members. A total of 3174 hours were provided (108%). This is equal to last quarter.
- 12. Impacts on these hours included 837.75 hours that were not provided due to public holidays or consumers exercising their right of choice and cancelling services to attend to other commitments. Had these hours been delivered domestic assistance would have achieved 138% which is accommodated by the flexible delivery model assigned to Service Group 1 as describe in paragraph 7.
- 13. During the course of 2014/2015 Community Care was contracted to provide a total of 11,710 hours of domestic assistance to eligible community members. A total of 13,077 hours were provided (112%). This is a 17% increase from 2013/2014.

Respite (Service Group 1)

- 14. During this quarter Community Care was contracted to provide 450 hours to eligible community members. A total of 96 hours were provided (21%). This is a 2% decrease from last quarter.
- 15. Impacts on these hours included 52.5 hours that were not provided due to public holidays or consumers exercising their right of choice and cancelling services to attend to other commitments. Had these hours been provided, Respite would have achieved 33%.
- 16. During the course of 2014/2015 Community Care was contracted to provide a total of 1800 hours of respite to eligible community members. A total of 418 hours were provided (23%). This is an 8% increase from 2013/2014.

Other Food Services (Service Group 1)

17. During this quarter Community Care was contracted to provide 96 hours to eligible community members. A total of 13 hours were provided (13.5%). This is a 5% decrease from last quarter.

- 18. Impacts on these hours included 1.25 hours that were not provided due to public holidays or consumers exercising their right of choice and cancelling services to attend to other commitments. Had these hours been provided, Other Food Services would have achieved 15%.
- 19. During the course of 2014/2015 Community Care was contracted to provide a total of 386 hours of other food services to eligible community members. A total of 79 hours were provided (20%). This is equal to 2013/2014.

Social Support (Service Group 1)

- 20. During this quarter Community Care was contracted to provide 1875 hours to eligible community members. A total of 766 hours were provided (41%). This is a 1% decrease from last quarter.
- 21. Impacts on these hours included 105.25 hours that were not provided due to public holidays or consumers exercising their right of choice and cancelling services to attend to other commitments. Had these hours been provided Social Support would have achieved 46%.
- 22. During the course of 2014/2015 Community Care was contracted to provide a total of 7500 hours of social support to eligible community members. A total of 3193 hours were provided (43%). This is 9% increase from 2013/2014.

Personal Care (Service Group 1)

- 23. During this quarter Community Care was contracted to provide 936 hours to eligible community members. A total of 250 hours were provided (27%). This is a 3% decrease from last quarter.
- 24. Impacts on these hours included 67.5 hours that were not provided due to public holidays or consumers exercising their right of choice and cancelling services to attend to other commitments. Had these hours been provided, Personal Care would have achieved 34%.
- 25. During the course of 2014/2015 Community Care was contracted to provide a total of 3748 hours of personal care to eligible community members. A total of 1021 hours were provided (27%). This is 2% decrease from 2013/2014.

Centre Based Day Care (Service Group 4)

- 26. During this quarter Community Care was contracted to provide 9981 hours to eligible community members. A total of 8162 hours were provided (82%). This is a 4% decrease from last quarter.
- 27. Impacts on these hours included 4002 hours that were not provided due to public holidays or consumers exercising their right of choice and cancelling services to attend to other commitments. Had these hours been provided, Centre Based Day Care would have achieved 122%.
- 28. During the course of 2014/2015 Community Care was contracted to provide a total of 39,924 hours of social support to eligible community members. A

total of 32,913 hours were provided (82%). This is 7% increase from 2013/2014.

Meals on Wheels (Service Group 6)

- 29. During this quarter Community Care was contracted to provide 1500 meals to eligible community members. A total of 1294 meals were provided (86%). This is a 2% decrease from last quarter.
- 30. Impacts included 342 meals that were not provided due to public holidays or consumers exercising their right of choice and cancelling services to attend to other commitments. Had these hours been provided, Meals on Wheels would have achieved 109%.
- 31. During the course of 2014/2015 Community Care was contracted to provide a total of 6000 meals to eligible community members. A total of 5388 meals were provided (90%). This is 40% increase from 2013/2014.

Transport (Service Group 7)

- 32. During this quarter Community Care was contracted to provide 6816 one way trips to eligible community members. There were 4106 one way trips provided (60%). This is a 0.5% increase from last quarter.
- 33. Impacts included 1691 one way trips that were not provided due to public holidays or consumers exercising their right of choice and cancelling services to attend to other commitments. Had these hours been provided, Transport would have achieved 85%.
- 34. During the course of 2014/2015 Community Care was contracted to provide a total of 27265 one way trips to eligible community members. A total of 16,007 one way trips hours were provided (59%). This is 4% increase from 2013/2014.

Consumer Support Information and Advocacy (Service Group 9)

- 35. During this quarter Community Care was contracted to provide 645 hours to eligible community members. A total of 182 hours were provided (28%).
- 36. During the course of 2014/2015 Community Care was contracted to provide a total of 2574 hours of consumer support information and advocacy to eligible community members. A total of 1065 hours were provided (41%). This is 2% decrease from 2013/2014.

Home Maintenance (Service Group 10)

- 37. During this quarter Community Care was contracted to provide 1788 hours to eligible community members. A total of 1414 hours were provided (79%). This is a 4% decrease from last quarter.
- 38. In November 2014, the Shire ceased accepting new referrals for Home Maintenance due to a change of staffing arrangements resulting in a risk of not being able to fulfil consumer requests.

- 39. Impacts on these hours included 144.5 hours that were not provided due to public holidays or consumers exercising their right of choice and cancelling services to attend to other commitments. Had these hours been provided, Home Maintenance would have achieved 87%.
- 40. During the course of 2014/2015 Community Care was contracted to provide a total of 7166 hours of home maintenance to eligible community members. A total of 6136 hours were provided (86%). This is 14% increase from 2013/2014.

COMMUNITY VISITORS SCHEME

- 41. During this quarter Community Care was contracted to provide 270 visits to eligible residents in approved Commonwealth Funded residential facilities. There were 291 visits provided (107%).
- 42. During the course of 2014/2015 Community Care was contracted to provide a total of 1080 visits. A total of 1136 visits were provided (105%)

HOME CARE PACKAGES LEVEL 2

- 43. During this quarter Community Care was contracted to provide 20 packages to eligible community members. A total of 15 packages were provided (75%).
- 44. Referrals for packages come from the Aged Care Assessment Team (ACAT). Community Care do not screen for eligibility nor assess potential consumers for services and as such, we are dependent on these referrals to maintain and increase service levels.
- 45. Home Care Packages are being transitioned to Consumer Directed Care Packages as of 1 July 2015. Community Care are preparing an implementation plan to drive this program, procedural and cultural change.

COMMUNITY ENGAGEMENT REQUIREMENTS

48. During this quarter Community Care conducted a feedback survey with day centre consumers to determine their level of satisfaction with the fresh daily prepared meals.

The outcome was positive with the findings showing that:

- 75% of participants were satisfied with the meal size,
- 97% of participants were satisfied with the presentation of meals,
- 100% of participants were satisfied with the quality of the meals, and
- 99% of participants were satisfied with the variety of the meals.

49. Community Care are currently conducting a HACC service wide satisfaction survey.

FINANCIAL CONSIDERATIONS

- 50. The Community Care Program (HACC) had anticipated a small surplus for the 14/15 financial year. The program, however, has returned an operating deficit of \$73,508. While provision had been made through the year for annual and long service leave a further \$133,635 was required when the leave provisions were reconciled. A number of staff have reached eight years of service and this alters the probability calculation for long service leave.
- 51. The provisions will be reviewed when the HACC audit is carried out by the Shire auditors so the HACC financials are not yet finalised. Any deficit can be carried forward to the 15/16 financial year.
- 52. The Meals on Wheels Program has an operating deficit of \$25,884.

- 58. The transition of Home Care Packages to Consumer Directed Care Packages is moving forward and it is anticipated that Community Care will be on track to commence the formal transition of our existing package consumers in June prior to the required 1 July 2015 timeframe.
- 59. Community Care are working closely with National Disability Insurance Scheme (NDIS) to transition HACC people under the age of 65 who have successfully explored NDIS eligibility to an NDIS support plan.

PURPOSE

1. To approve proposed amendments to the Community Groups Lease Policy (Attachment 2), that will provide Council with a policy position to deal with Community Groups who refuse to sign the Council adopted Community Groups Lease.

BACKGROUND

- 2. At the Ordinary Council Meeting on 25 February 2013 Council adopted Lease Policy LEA1 – Community Groups Lease Council Policy (the Policy) (Attachment 1).
- 3. The Policy was designed to provide greater transparency and equity in administering the lease of facilities to Community Groups and its implementation has been very successful.
- 4. As part of the implementation process, the Shire has worked closely with user groups to improve and clarify the Lease Agreements.

DETAILS

- 5. There are currently a small number of user groups who have refused to sign the Lease Agreement as specified within the Policy. The current Community Group's Lease Policy provides for a dispute resolution process. This process applies where a user group with a signed a Lease Agreement is in dispute with the Shire over interpretations relating to the Agreement.
- 6. The Shire does not currently have a clear policy position regarding user groups who have not signed a Lease Agreement.
- 7. It is proposed that the Community Group's Lease Policy be amended to provide Council with a policy position to enable the management of user groups who are not subject to an approved Lease Agreement.

8. It is proposed the Community Group's Lease Policy be amended to stipulate that user groups who do not sign the Lease Agreement will be offered the use of facilities under a Facility Hire Agreement (Attachment 3), through the inclusion of the following paragraph in the Policy Statement:

Community Groups unwilling to sign a Lease Agreement in accordance with this Policy, will be required to hire the facilities in accordance with the Shire's Casual Facility Hire Agreement at the rate applicable for the facility.

- 9. It is essential any agreements clearly outline the nature of the hire arrangements, roles and responsibilities of parties to the Agreement and outline fees and charges payable under the agreement. Importantly, under a Facility Hire Agreement, the user group will not have exclusive use of the facility.
- 10. The Shire's preferred position is to have user groups operating under the Community Group's Lease Agreement.

STATUTORY AND LEGAL CONSIDERATIONS

11. Section 3.58 Disposing of Property in the *Local Government Act 1995* states: "Dispose includes to sell, lease or otherwise dispose of, whether absolutely or not"

POLICY CONSIDERATIONS

12. The amendment to this policy will address a current policy gap and will provide the Shire with a clear position for handling situations in which user groups choose not to sign the adopted Community Group's Lease Agreement.

COMMUNITY ENGAGEMENT REQUIREMENTS

- 13. The original policy was referred to all User Groups for comment. Following assessment of the comments meetings were held with 39 User Groups to discuss a proposed way forward.
- 14. Since the adoption of the Community Group's Lease Agreement in February 2013, the Shire has met regularly with User Groups to ensure Lease Agreements are operating effectively.

FINANCIAL CONSIDERATIONS

15. The proposed amendment to the Community Groups' Lease Policy will ensure financial arrangements are clear and there is equity and consistency in the way the Shire's User Groups are managed.

- 22. The proposed Policy amendments will provide the Shire with a policy position to enable the management of user groups that are not subject to an approved Lease Agreement.

PURPOSE

1. To consider supporting one application for funding through the Department of Sport and Recreation's (DSR) Community Sport and Recreation Facilities Fund (CSRFF) Annual Grants Round.

BACKGROUND

- 2. Through the CSRFF program, the State Government provides financial assistance to community groups and local government authorities to develop basic infrastructure for sport and recreation. The program aims to increase participation in sport and recreation with an emphasis on increasing physical activity through the provision of well-planned facilities.
- 3. The Shire's role in the provision of the funding is to call for applications, assess them in priority order and rate each application received (Attachment 1).
- 4. The maximum grant approved will be no greater than one third of the total estimated project cost.
- 5. There is no obligation on the local government authority to make any contribution to a project.
- 6. All applications for this annual grants round are to be received by the DSR by 4pm on the last working day of September 2015 for assessment.
- 7. Successful applicants will be advised in February 2016, with funds to be expended by 15 June 2017.

DETAILS

8. The Shire of Kalamunda has one external application for the DSR's CSRFF 2015/16 Annual Grants Round.

Hills BMX Club

- The application is for a proposed re-design of the Start Gate Ramp from
 2.5 metres to 5 metres, also enabling an upgrade and refurbishment of the club rooms at the BMX track at Ray Owen Reserve in Lesmurdie.
- 10. The Project will contribute to the sustainability of the BMX Club with improved facilities allowing the Hills BMX Club to retain and attract a strong membership base and better accommodate the wider BMX community.
- 11. Specifically, the Project will allow the Club to remain competitive within the sporting market by providing an updated facility to attract local, State and National competitors and competitions to the venue.
- 12. The Club has provided a cost estimate for the project of \$226,350. Based on the standard one third each split, the proposed cost contribution is as follows:

FINANCIAL CONSIDERATION

- 16. The Shire of Kalamunda's contribution towards the proposed projects will be dependent on the outcome of the CSRFF applications and is proposed to be considered as part of the 2016/17 budget process.
- 17. The Hills BMX Club have indicated they would be willing to fund up to two thirds of the project should the Shire of Kalamunda not be in a position to provide funding assistance.

18. At present, within the Long Term Financial Plan, \$100,000 (2018/19), \$2.5 million (2019/20) and \$2.5 million (2020/21) respectively has been allocated towards the implementation of the Ray Owen Master Plan, which supported this project.

OFFICER COMMENT

- 24. Through the CSRFF program, the State Government provides financial assistance to community groups and local government authorities to develop basic infrastructure for sport and recreation. The program aims to increase participation in sport and recreation with an emphasis on increasing physical activity through the provision of well-planned facilities.
- 25. The DSR requires all applications to be assessed by each local government authority and provided with a ranking according to the local government's assessment. It should be noted, there is no obligation on the Shire to support a project.
- 26. This project has been ranked as the first and only priority in regards to facility development within the Shire of Kalamunda.
- 27. The BMX Club has noted a marked increase in membership within the last five years and their existing facility is unable to cope with the current and projected participation numbers. The track itself is in good condition however, the starting ramp does not currently provide the National and State height required (5m) for the Club to bid to host State, National and International events.
- 28. Club facilities are ageing with the first aid room currently housed within a rusting sea container. The clubroom and office areas are small and need extending to provide adequate facilities to the growing membership.
- 29. The proposed facility development will allow the Club to better accommodate existing membership in addition to positioning the Club to attract bigger events and competitors from the State, National and International BMX community.
- 30. The need for an upgraded, refurbished clubroom facility and a new five metre starting ramp is supported by the findings within the Ray Owen Master Plan (endorsed by Council February 2015).

A Councillor queried whether it was really necessary for the Shire to allocate \$75,450 to this project when the Hills BMX Club have indicated they would be able to increase their proportion and there may be other sporting clubs in more need of financial support.

The Manager Community Development commented that a contribution up to a third by the local government was the normal practice for grants of this nature. The Chief Executive Officer noted this will be brought back to budget next year which will give Council the opportunity to decide if this is considered a priority project or not.

Hill's BMX Facility upgrade

Hills BMX club is seeking assisting funding from DSR to re-design the start gate from 2.5 meters to 5 meters in height also clubroom upgrade to improve the facility to required UCI standards and attract local, state and national level BMX competitions to Hills in the future.

The start gate will be extended in height and length to accommodate additional office, first aid and storage rooms beneath the ramp. Supporting structures to be constructed of "concrete box culvert tunnels" as a cost effective and lasting solution to house transportable offices and storage area.

<u>Start ramp:</u>

Clubrooms:

Present clubrooms house toilets, kitchen and office. Due the expansion of our club's members in recent years the current building is proving too small for the club's needs. The office is too small during racing events and also the 2 small toilets are inadequate for the large volume of participants and supports during weekly race nights.

Below is a floor plan of the current layout:



Our new proposed lay out would move the existing office to the new office built under the new start ramp allowing for a greater toilet area. Kitchen and servery area would be relocated with several upgrades to comply with current health standards.

New proposed clubroom layout:



Our principle aspect of requested upgrades is to provide a competitive and attractive facility to allow local and regional riders to practice and participate in the growing sport of BMX. Hill's BMX facility originates from the early 80's and is in desperate need of the upgrades to continue to grow as a healthy club. With the upgrades it can also move its first aid room currently located in a shipping container into the office area provided under the ramp. The upgrade will also result in the removal of two unsightly sea containers currently located onsite to provide storage and first aid.

Expected cost for start gate upgrade including relocation of roof structure, supply and install culverts, earthworks, fencing, relocation of gate and bitumen works: **\$129,000**

Supply and connection of transportable offices including vandal proof entry doors: \$32,500

Clubroom upgrade: \$64,850

Total project budget: \$226,350 + GST

PURPOSE

1. For Council to receive the Pioneer Park Master Plan (Attachment 1).

BACKGROUND

- 2. Pioneer Park is Crown Land vested with the Shire for the purposes of recreation and is located in Forrestfield. The Reserve is approximately 57ha in size and is currently home to the Kalamunda/Canning Rugby League Club (KCRLC).
- 3. Prior to Pioneer Park being used for recreation and sporting pursuits, the land was formally used as a landfill site, operating from 1975 and closing in July 1997.
- 4. From 2008 to 2010 Pioneer Park was established inclusive of access roads and car parks for the purpose of use for recreation and sporting pursuits.
- 5. Consequently, given the chequered history relating to previous land use and subsequent remediation a number of issues have been experienced at the site. This has included an unstable surface caused by subsidence and soil consolidation, which has resulted in infrastructure such as flood lighting having to be removed due to safety concerns.
- 6. Due to the complex nature of the issues being experienced at Pioneer Park, the Shire has undertaken a number of studies and investigations in to potential solutions and alternative sites including the Darling Range Master Plan and an Environmental Impact Assessment of Pioneer Park.
- 7. The Darling Range Master Plan was endorsed by Council in July 2013, identified the need to undertake a Master Planning process at Pioneer Park.
- 8. The key factors providing the catalyst for the development of the Master Plan included:
 - a. A number of issues with the integrity of the playing surface i.e. subsidence, drainage etc. that have caused the playing surface to be unsuitable for play.
 - b. Supporting infrastructure having been previously removed because of subsidence.

- c. The age and condition of the existing infrastructure.
- d. The need to identify a long term home for the Kalamunda and Districts Rugby League Club.
- 9. A Community Sport and Recreation Facilities Fund (CSRFF) application was then submitted to the Department of Sport and Recreation (DSR) in 2014 to engage a consultant to assist in undertaking a Master Plan study and subsequently the Shire was successful in obtaining a grant of \$18,333.
- 10. In mid-2014, AECOM were engaged to develop the Pioneer Park Master Plan.
- 11. In August 2015, Councillors received a presentation from AECOM on the Pioneer Park Master Plan. As such, the Master Plan is now presented for Council to receive.

DETAILS

- 12. The Pioneer Park Master Plan investigated the feasibility of remediating and redeveloping the Pioneer Park playing fields.
- 13. The Master Plan process included a significant amount of research into previous studies, an audit and review of facilities, community consultation and costing of options.
- 14. The Master Plan has estimated the total cost of remediating the site to be in the region of \$30-\$50 million plus associated building and infrastructure costs.
- 15. A summary of the key recommendations has been outlined below:
 - That the Shire meet with rugby and softball clubs to discuss the outcomes of the Master Plan.
 - As an interim solution, relocate the KCRLC immediately to Morrison Oval at Hartfield Park Reserve.
 - Undertake a feasibility study at Maida Vale Reserve to consider potential of converting existing netball courts into rectangular and diamond playing fields.
 - Investigate possibilities and availability of purchasing freehold land within the Forrestfield area as development occurs.
 - Consider other possible land uses for Pioneer Park.

16. Of the key actions outlined within the Master Plan, the priority short-term action is to work with the KCRLC and relevant clubs based at the Hartfield Park precinct to determine a suitable ground and home for them to train and play in 2016.

COMMUNITY ENGAGEMENT REQUIREMENTS

- 19. A significant amount of community consultation was undertaken during the development of the Master Plan, including preliminary discussions being held with all clubs based at the Reserve, relevant state associations, neighbouring local government authorities and local schools.
- 20. Further consultation will be required with affected clubs based at the Reserve to confirm Pioneer Park is no longer a viable site for sport and then enable alternative options at the Hartfield Park precinct to be considered.

FINANCIAL CONSIDERATION

- 21. The Pioneer Park Master Plan has estimated remediation costs for the site would be in the vicinity of \$30-\$50 million, with a further \$9.6-\$9.9 million required for construction works.
- 22. Within the Long Term Financial Plan no funds that have been specifically set aside for the development of a new rugby league facility. However funds totalling \$2M (made up of four amounts x \$500,000 per year, commencing in 2017/18) has been included for the upgrading of Pioneer Park playing fields and additional capping works.
- 23. Given redeveloping facilities at Pioneer Park is no longer considered feasible, there is an option to consider reallocating these funds towards new facilities should be required.

OFFICER COMMENT

- 29. The Pioneer Park Master Plan findings and associated costs have confirmed an investment of \$30-\$50 million for site remediation and a further \$9.6-\$9.9 million will be required for construction of sporting fields.
- 30. The findings confirm it is not financially viable to invest significant funding into remedial works and construction for it to be safe and suitable again for sports activity.

- 31. Given the key findings of the Master Plan, it is suggested the Shire undertake individual follow up with the affected user groups, as opposed to a period of public comment.
- 32. The KCRLC are the only existing user group and will now require an alternative location to play and train for the 2016 season and beyond.
- 33. As an interim solution, the Pioneer Park Master Plan recommends the relocation of the KCRLC immediately to Morrison Oval at Hartfield Park Reserve.
- 34. The Shire is supportive of this recommendation on the basis that KCRLC affiliated junior members have been operating at Morrison Oval for the past two years, utilising the club room facility. The major benefit to the arrangement being that rugby and cricket operate during alternate sporting seasons (winter/summer).
- 35. Morrison Oval is currently shared between Forrestfield United Soccer Club, Forrestfield Cricket Club and more recently the Kalamunda and Districts Rugby Union Club (KDRUC) have also been using the field to access the training lighting given the lighting on the Rugby fields has been inadequate.
- 36. The floodlighting on the rugby union fields are currently being upgraded as part of the Hartfield Park Master Plan for both training and competition purposes, this will minimise the current need for KDRUC to train on the Morrison Oval and enabling KCRLC to utilise the Morrison Oval site.
- 37. The extension of grounds at Morrison (cricket) Oval, with works to be completed by June 2016 is another supporting element to the proposed short-term move, providing greater capacity for shared use by the KCRLC and FUSC.
- 38. In terms of the preferred longer term approach, Council has recently supported the submission of a CSRFF application to the DSR to undertake a feasibility study to consider a shared, multi-purpose club room facility at Hartfield Park that would consider the needs of a variety of potential user groups.
- 39. An alternative long term approach, to be investigated in the future and referenced in the Pioneer Park Master Plan, is a feasibility study into maximising future sports use at the Maida Vale Reserve. The need for a Master Plan for the Maida Vale Reserve was supported within the Community Facilities Plan however was not deemed a high priority, therefore no funds have been identified within the Long Term Financial Plan to undertake this study within the next 10 years.

PURPOSE

1. To consider an application from the Pickering Brook Sports Club (the Club) for sponsorship from the Shire for the inaugural Pickering Brook Stone Fruit Festival (the Festival) in February 2016.

BACKGROUND

- 2. The Club proposes to organise and host the inaugural Pickering Brook Stone Fruit Festival on Saturday 13 February 2016.
- 3. The Club seeks sponsorship from the Shire in the sum of \$15,000 plus GST. Sponsorship is also being sought through a number of other sources including Lotterywest.

DETAILS

- 4. The concept of the Festival is to establish a flagship annual event focusing on and celebrating the provenance and quality of fresh local produce.
- 5. The Festival organisers plan to create an event that will be a culinary experience including cooking demonstrations and showcasing local produce. The event will be a celebration of food and drink with seasonal stone fruit at the forefront. It will include tastings of local seasonal produce, cider, wine and other locally produced food and drink.
- 6. The Festival organisers have engaged a professional event organiser to assist with the event development, budget and logistics of the inaugural event.

STATUTORY AND LEGAL CONSIDERATIONS

7. Section 3.1 *Local Government Act 1995* permits sponsorship contributions to be made.

OFFICER COMMENT

23. The Shire of Kalamunda Events Strategy focuses on developing events that provide economic value to the community and raise the profile of the area as a destination to potential visitors. The Pickering Brook Stone Fruit Festival should achieve this outcome if the organisers can deliver an ambitious inaugural event.

Festival organisers have demonstrated an increased capacity to deliver the event by engaging the same professional event organiser that was responsible for the successful Astronomy Lesson World Record in February 2015. The Pickering Brook Stone Fruit Festival Event Plan is shown as (Attachment 1).
 Council has previously endorsed the Hills Rural Study which foreshadowed the need for growers to diversify and add value to produce. This event will create an opportunity for growers to showcase value-added products and promote to a wider audience.
 Using tourism economic impact modelling forecasts, visitor numbers of 2,000 at the Pickering Brook Stone Fruit Festival 2016 would represent a direct benefit the local economy of approximately \$214,000.

INTRODUCTION

An initiative of the Pickering Brook Sports Club, it is proposed that the first Stone fruit focused festival be held at the Pickering Brook Sports Club Oval on Saturday 13 February 2016. This summer event will include tastings of local seasonal produce, cider, wine, food, Celebrity Chefs, cooking demonstrations and children's activities.

Whilst showcasing locally grown produce is the central focus of this festival, it is envisioned that the 2016 Stonefruit Festival will bring economic benefits to the local community and beyond through the attraction of high numbers of visitors to the region.

Pickering Brook is a part of the Eastern Rural Districts area of the Shire of Kalamunda and is bordered by Carmel, Bickley, Hacketts Gully, Paulls Valley and the Korung National Park. One of WA's most prolific stone-fruit growing regions, Pickering Brook is a mix of State Forest, catchment areas, hobby farms, orchards and vineyards.

STONEFRUIT FESTIVAL OBJECTIVES

- Establish a flagship annual Stone Fruit festival in the Perth Hills, focusing on and celebrating the regions growers and the Pickering Brook area.
- Strengthen the community spirit and pride in the unique culture and heritage of Pickering Brook.
- Provide sales and marketing opportunities to local growers and producers.
- Provide a program of events which engages and educates people on healthy eating and locally grown and in-season produce.
- Build the Perth Hills and Pickering Brook reputation as a major destination for guality locally produced food and wine.
- Showcase the regions environment, history and community spirit through inclusive Stone fruit themed, low cost accessible activities
- To add to the events prestige by attracting acclaimed Chefs to present Cooking Demonstrations and other activities
- To assist in building Western Australia's reputation as a producer of quality stone fruit.

FESTIVAL NAME

The name of a festival needs to summarise the theme of the event. As a general rule the name should be short and relevant as lengthy labels can be difficult to remember. By hearing or reading the name once, people should be able to recognise the event and have a sense of what it is about. Common, but precise, terms that are on topic are the building blocks of a strong event title. It should also be easy to pronounce and pleasant to hear.

It is recommended that the name of the festival be 'Pickering Brook Stonefruit Festival' which encapsulates the above elements.

TARGET AUDIENCE

35 to 60 year olds who live both locally and in the wider Perth area, with an interest in fresh food, wine and live entertainment.

Families who live both locally and in the wider Perth area, seeking to access affordable entertainment in a well-managed and safe environment.

Visitors from regional Western Australia, Interstate and Overseas with an aim to showcase the Perth Hills.

TICKET PRICE

The ticket price for a festival must be appropriate for the target audience and provide a revenue stream. It is proposed that the tickets be priced as follows.

Adults \$10.00 per head Cost includes entry and can include product sampling.

Children under 12yrs free

Tickets will be pre-sold online via a ticket selling website (EventBrite, TryBooking etc.) and at the gate.

FESTIVAL ELEMENTS

- Big Top Marquee fruit tasting and sales
- Kitchen Stage cooking demonstrations by celebrity chefs and local talented chefs, jam making demonstration, cooking with kids
- Entertainment Stage music, peach eating competition etc.

- Local Produce stalls food, cheese, chocolate, asparagus etc.

FUNDING APPLICATIONS

LOTTERYWEST

A funding application must be submitted to Lotterywest on or before the 1 August 2015. As a general rule, grants by Lotterywest are to complement other sources of support, including a contribution from the organisation's own resources. Lotterywest can also assist with combining their grant with other sources of funding.

SHIRE OF KALAMUNDA

A funding proposal must be submitted to the Shire of Kalamunda on or before the 1 August 2015. The proposal will be submitted to council in late August, the final decision on the funding amount will be decided at this time.

CORPORATE SPONSORSHIP INFORMATION

A professional sponsorship package illustrating commercial advantages and the 'fit' between the sponsor and the Stonefruit Festival is vital. This includes highlighting potential corporate objectives like social and community engagement, brand-related and sales objectives and media coverage.

The Stonefruit Festival sponsorship package can be developed to meet the needs of different types of sponsors, for example, Major Partner (naming rights) <\$25,000, Platinum Partner <\$10,000, Gold Partner <\$5000 and Corporate Partner <\$1000.

PURPOSE

1. To consider a request from Lesmurdie Tennis Club (the Club) for a lease term of 10 years plus an option of a further 10 year period (Attachment 1).

BACKGROUND

- 2. At the Ordinary Council Meeting held on 25 February 2013, Council adopted Lease Policy LEA1 – Community Groups' Lease Council Policy.
- 3. The Club's existing lease (with a term of five years and an option of five years) expired on 30 September 2009.
- 4. The Shire has been in negotiations with the Club for an extended period of time in attempting to resolve concerns regarding the structure of the Lease Agreement, particularly related to the responsibilities for maintenance and repairs. During that time briefings have been provided to Ward Councillors regarding the status of negotiations and the two parties have been working through a process to resolve the Club's issues.
- 5. The Club recently held a committee meeting to discuss the status of the Lease Agreement and confirmed that it was their intention to accept the current lease agreement, provided that the lease term would accommodate a term of 10 years and an option of a further 10 years. The Club was advised that an extended lease period could only be approved by Council
- 6. The Club's request for a lease period of 10 years plus an option of a further 10 years relates to their proposed significant capital investment into the playing surfaces which will result in the life span of these facilities extending well past the lease term. Current projections by the Club propose to invest more than \$100,000 into the replacement and improvement of their playing surfaces over the next five years.
- 7. The associated procedure noted that a typical lease term would be five years, however the Shire at its discretion, may consider a longer term where the term is required to support a loan arrangement or, in other extenuating circumstances, where approved by resolution of Council.

DETAILS

- 8. The Club is seeking a lease term of 10 years plus an option of a further 10 years on the grounds that they will be making lump sum capital contributions towards various renewal and maintenance works over coming years. It is envisaged that the total investment will exceed \$100,000 over the next five years.
- 9. The Club advises that it is likely that the first two synthetic courts will be replaced in 2016/17 with an annual cost of approximately \$40,000. The next two synthetic courts will be due for replacement in 2018/19. In addition, it is likely that a further \$30,000 will be required to resurface flexi pave courts in 2018/19. It should be noted that these costs are indicative and will be dependent on a number of factors, including available funding from the State Government.
- 10. The Club proposes to seek funding of the planned renewal and maintenance works through a variety of sources. They intend to seek support from the State Government, the Shire of Kalamunda and through their own capital contributions.

New Lease Document - Application for 10 Year Terms

I refer to the Shire's letter dated 9 January 2014.

 Thank you for clarifying procedures concerning negotiation of the term of the new lease.

In line with your clarification under "Comment 36" of that letter, we hereby provide written confirmation that the Club makes application for a 10 Year Term commencing 1 July 2013 and a Further 10 Year Term commencing 1 July 2023,

The circumstances are that we will, in all probability, be making lump sum capital contributions towards various renewal and maintenance works in and around the Lesmurdie tennis facility over the coming years. The contributions would be substantial of the order of thousands to tens of thousands of dollars in each case.

As you are aware, these works deliver outcomes which vest in the Shire and not the Club.

The way the Club can secure its investment is by way of a lease agreement with the Shire-

Also, these capital contributions deliver outcomes which have relatively long life spans of the order of 8-20 years. Logically, any lease agreement needs to operate over equivalent time spans. This ensures that the lessee gets full value from the capital contributions it has made.

In the foreseeable future, lump sum capital contributions are likely to be made for the following:

- Clubhouse extensions and refit final payment in the next few months with a remaining life span of 18 years
- Toilet/bathroom renewal in two years' time with a life span of 20 years
- Hard court resurfacing and net post/winder replacement in two years' time with a lifespan of 8 years

Synthetic grass court resurfacing and net post/winder replacement	- in one to five
years' time with a life span of 11 years	

- Court 4 light tower modification in one years' time with a life span of 20 years
- Thank you for clarifying your interpretation of Clause 18 "Option to Renew". However, from our point of view, the contentious part of this clause remains:

"...the Lessor shall grant to the Lessee a lease for the Further Term at the Rent and on terms and conditions similar to this Lease... and on such other terms and conditions as the Lessor may consider appropriate."

Our interpretation of this statement is that it gives the Shire absolute discretion to change the terms and conditions of any renewal as it sees fit. As such it defeats the purpose of an option to renew. To be of value, the terms of a renewed lease need to be predictable at the time of entering into the initial lease. Where that is not the case, any right to renew is of questionable value and cannot be relied on as providing certainty past the initial term.

We consider the wording of our expired lease (refer Clause 3. below) encapsulates a genuine option to renew and should be reflected in the new lease. Neither party has the right to make any unilateral changes to the terms of the lease.

OPTION OF RENEWAL

The Lessee having duly and punctually paid the rent hereby reserved and complied with, observed and performed all of the terms, covenants and conditions herein contained or implied on the part the Lessee to be complied with, observed by and performed shall have the option at the expiration of the term hereby granted of extending this Lease for the further term specified in Item 4 of the schedule exercisable by the written request of the Lessee made not more than six (6) months nor less than three (3) months prior to the expiration of the term specified in Item 2 of the schedule upon the same covenants, conditions and stipulations as are contained in this Lease (except for this present option of renewal) and the rent during the further term as agreed upon by the parties prior to commencement of the option term or as specified in Item 5 of the schedule.

We trust you will rule in our favour on these issues as outlined above and look forward to a positive outcome from Council.
