3.0 PUBLIC QUESTION TIME

A period of not less than 15 minutes is provided to allow questions from the gallery on matters relating to the functions of Council. For the purposes of Minuting, these questions and answers are summarised.

- 3.1 <u>Mr Tim Colgate</u> (Questions taken on notice 22 June 2015)
 - Q1. Given most local people would probably prefer to stay in their home as long as possible, has the Shire modelled the number of people from outside the Shire that are likely to take up residence in this proposed facility?
 - A1. No.
 - Q2. Was the Expressions of Interest for a Partnership Arrangement for the Development of Aged Car Facility's on Reserve 30314 authorised by Shire officers or a Council motion, and when did this authorisation occur?
 - A2. It was directed by the former Chief Executive Officer.
 - Q3. In the call for Expressions of Interest for the redevelopment of Reserve 303014 did the Shire advise of the cost of connecting to sewer, the requirement for Federal environmental assessment, the need to have the reserve rezoned in the Metropolitan Regional Scheme and the bushfire risk of the location?
 - A3. The expression of interest was for a partnership agreement for the development of Aged Care facilities and did not go into that depth of detail.
 - Q4. Resolution SMC156/2011 state *"That Bethanie Group Inc. be advised they are the preferred partner of the Shire of Kalamunda in the development of Reserve 30314 (40) Wilkins Road Kalamunda"*. In this context, what is the definition of preferred partner?
 - A4. The content of the Report for the meeting clearly articulates that there was an Expression of Interest process to identify a service provider to partner with the Shire to deliver a particular outcome for this site. As a result of that process Bethanie Group was selected as the preferred service provider to meet that outcome.
 - Q5. How will the Shire ensure that 100 beds are provided in the Residential Care facility?
 - A5. Options to ensure this outcome can be implemented through the Local Planning Strategy conditions or conditional agreements by the land owners
 - Q6. Have any negotiations with Bethanie Group Inc. been undertaken to develop a formal lease documentation?

- A6. No.
- Q7. What is the relevance of the Shire of Kalamunda's "preferred partner" arrangement with the Bethanie Group if neither party own the land?
- A7. Where a Reserve is involved the State Government will normally have an agreement in place through a Vesting Order for the local government to have "care, control and management" of the Reserve. These vesting orders will also include a provision for the Reserve to be leased to another organisation, with the approval of the Minister for Lands. Point 3 of the Council resolution clearly states that all relevant statutory approvals would be needed before negotiations to develop a lease agreement would proceed.
- Q8. Who is the current Minister for Works?
- A8. There is no specific Minster for Works. These responsibilities fall within the State Development portfolio. The Premier has responsibility for this portfolio and is assisted by Hon Terry Redman MLA
- Q9. Has either the Shire of Kalamunda or Bethanie Group approached the Minister for Works to transfer ownership of Reserve 302314, if so what was the outcome?
- A9. The Shire has made a request for the land however there has been no outcome.
- Q10. As the Reserve (30314) is not vested with the Shire, why has the Council instructed the Shire to act as the proponent for the MRS rezoning and EPBC approvals processes?
- A10. As indicated in the answers to Q9 and Q7 the Shire was seeking to have all statutory approvals in place, including control/ownership of the land and therefore these matters were progressed to ensure where possible processes were streamlined.
- Q11. Did the Shire pay the Bethanie Group to provide the concept plan for the EPBC referral and update the concept plan for the EPBC assessment?
- A11. No.
- Q12. Does the current concept plan for the integrated aged care facility on Wilkins Road meet the requirements of State Planning Policy and the draft State Planning Policy 3.7 Planning for Bushfire Risk Management? If not, what changes would be needed to meet those requirements?
- A12. There is insufficient information in a concept to assess every detail of the State Planning Policy.

- Q13. With regard to critical planning considerations, such as bushfire risk and evacuation plans, the Shire appears to be deferring assessment of these until later planning approval stages. What will the Shire actually be assessing in it consideration of Amendment No 55 of the Local Planning Scheme to rezone the land?
- A13. The amendment deals with what is the most appropriate zone of the land if the MRS is zoned Urban.
- Q14. What is the purpose of developing a concept plan if it cannot be used to assess the proposed development?
- A14. To study the size and potential yield of the site.
- Q15. Why is the Shire of Kalamunda Proponent for a proposed development on land owned by the State Government?
- A15. The Shire has been instructed by Council to progress the matter.

1. To receive the report on rates debtors for the period ended 30 June 2015 (Attachment 1).

- 3. A total of 8,858 ratepayers have taken up an instalment option. Of these 1466 have chosen to pay by two instalments and 7392 have chosen to pay by four instalments. Any amounts outstanding by those ratepayers without an instalment option are regarded as defaulted.
- 4. The Shire can accept a direct debit payment arrangement to finalise the balance or a special payment arrangement is made in extenuating circumstances. Strict protocols are maintained so that the Shire is seen to be fair and equitable to all ratepayers.
- 5. The Shire of Kalamunda now offers direct debit arrangements for instalments, however at this stage there has been little response.
- 6. As noted on (Attachment 1), the Shire has collected \$30,523,297 or 98.7% of the debt from the date the rates and service charges were raised, compared to 97.4% at the same period last year.

7. There were no interim rates raised in June 2015 to allow rates modelling and billing, therefore the figure remains at \$385,987 raised so far. This is in line with the revised budget projections of \$380,000.

DETAILS

- There remains 24 Ratepayers from 2013/2014 with outstanding debts. The next step is for the Shire to proceed with Land Warrants. A briefing session was provided to Council in June 2015. Councillors have been provided with details and contact information.
 - The Shire has issued 254 General Procedure Claims through the Courts for the 2014/15 rates and service charges outstanding. Of these 254, the Shire obtained default judgement on 77 properties. A total of 173 of these matters have been closed due to payment being received. Four matters are being defended by the ratepayers.
 - Of the 77 properties where default judgement has been obtained a total of 60 properties have had a Property Seizure and Sales Order (PSSO) Goods issued or are awaiting issue through the Courts.

9. The Shire collects its rates debts in accordance with the *Local Government* Act (1995) Division 6 – Rates and Service Charges under the requirements of subdivision 5 – Recovery of unpaid rates and service charges.

PURPOSE

1. To provide Council with statutory financial reports on the activity of the Shire of Kalamunda with comparison of the year's performance against adopted budget. This Statement compares the actual results for the year with the budget.

BACKGROUND

- 2. The Statement of Financial Activity (Attachment 1), incorporating various sub-statements, has been prepared in accordance with the requirement of the *Local Government Act 1995*, *Local Government (Financial Management) Regulations 1996* (Regulation 34).
- 3. The 2013/2014 financial position was finalised on the 12 November 2014, the opening funding position in the Statement of Financial Activity statement reflects the audited position.
- 4. The budget column reflected matches to the second budget review approved by Council at its meeting on 23 March 2015.

DETAILS

5. The *Local Government Act 1995* requires Council to adopt a percentage or value to be used in reporting variances against Budget. Council has adopted the reportable variances of 10% or \$50,000 whichever is greater.

Financial Commentary

Draft Statement of Financial Activity by Nature and Type for year ended 30 June 2015

6. This Statement reveals a net result surplus of \$5,634,139 against budget for the same period of \$2,481,379. The reasons for the variance include, timing issues on the Capital projects Hartfield Park and Kostera Oval infrastructure and from Operating costs, materials and contracts costs.

> The Financial Statements presented are in a draft stage and are subject to the final audit and there are pending journals that are still being finalised which will have an effect on the final results.

Major journals yet to be passed are:

- Provision for annual and long service leave;
- Impairment loss on demolished/un-used Shire buildings in the year;
- Revaluation of infrastructure assets for which the final report has yet to be finalised; and
- Accruals on late supplier invoices.

Revenue

- 7. Total Revenue excluding rates is over budget by \$55,022. This is made up as follows:
 - Operating Grants, Subsidies and Contributions are over budget by \$22,354 which is within the reporting threshold.
 - Fees and Charges variance is over budget by \$93,852. This is coming from the following areas:
 - Realisation of unused rebates from the Smokebush Estate as a result of finalisation of claims \$29,639;
 - Higher number of dog registrations \$27,176;
 - Additional sale of scrap metal \$24,848.
 - Interest earnings are slightly over by \$39,171 which is within the reporting threshold. Achieving the result above budget of \$1,116,503 in a challenging environment is mainly due to close monitoring of cash flows. The challenges are a combination of:
 - Lower interest income from deposits with Approved Deposit taking Institutions (ADI's) where the returns are lower than forecast. The cash rate was reduced by the RBA in June 2015 by 25 basis points to a new low of 2.00%; and
 - The returns will be further constrained with the implementation of Basel III banking regulations which are effective from 1 January 2015, which requires all ADI's to keep a higher capital ratio against their liabilities.

• Other Revenue is slightly under budget by \$15,052. Most "Other Revenues" comprise of various fines and penalties, these are difficult to predict.

Expenditure

- 8. Total expenses are under budget with a variance of \$2,199,020. The significant variances within the individual categories are as follows:
 - Employment Costs are under budget by \$90,203 due to some vacant positions predominantly in the operational business units. This has had an impact on the capacity to deliver infrastructure projects. Some of the variance will be offset on finalisation of accruals for annual and long service leave for the year end.
 - Materials and Contracts is under budget by \$1,130,392 which is comprised of:
 - Reduced expenditure on consultancy costs, \$229,266. The sum of \$89,129 relates to asset management for which not all of the budget is expected to be utilised in 14/15 as the revaluation of infrastructure will not be finalised until mid-July;
 - Reduced maintenance costs related to the building asset class, approximately \$236,472 under expenditure so far which is a testament of the condition of the buildings from what was envisaged;
 - Reduced waste management costs, mainly coming from lower verge collection costs, \$737,898. This is however being offset by higher costs incurred for tipping charges and transfer station costs emanating from greater tonnage being received than forecast. Once the audit is finalised, the surplus will be transferred to the Waste Management Reserve whereby the monies will be used to upgrade facilities, plant and equipment; and
 - Project expenditure is under budget by \$142,646. Most of the variance relates to environmental projects of \$99,146. While some of it is timing due to seasonality of work to be carried out such as weeding and spraying, other projects which are on ground works such as the Woodlupine Stream project won't meet budgeted expenditure.
 - Utilities were over budget by \$106,725. Street lighting is just over budget by \$8,137 with most of the higher costs incurred in the area of Bushland reserves, \$32,847 where water and electricity costs surpassed budgets.
 - Depreciation, although a non-cash cost, is tracking under budget, reporting a variance of \$881,457 with the largest component coming from Hartfield Park Recreation Centre \$245,681 and Ray Owen Sports

Centre, \$150,794. The reason for the variance can be attributed to the buildings depreciation which has significantly reduced due to the valuation exercise undertaken at the end of the 2013/14 financial year. The depreciation on this building was not correctly adjusted at the budget review.

- The interest expense is slightly under budget by \$35,314, which is the result of a timing difference between amounts accrued and the budget which is based on the debenture payment schedule.
- Insurance expense is slightly under budget by \$7,434 which is within the reporting threshold.
- Other expenditure is under budget by \$309,582, with the bulk of the variance relating to refund of surplus monies on HACC projects for 2013/14, comprising \$212,238.

Capital Revenues

Non-operating Grants and Contributions

- 9. The non-operating grant income is lower than the budget by \$999,456.
 - It should be noted that there will be no claims to be made for the Roads to Recovery programme as the identified roads are still works in progress. As per the guidelines, the impact of this delay is that the claim for 2014/15 will be pushed out to year five of the current grant programme. This will result in a budget variance of \$518,794; and
 - \$248,379 related to Public Open Space funds not claimed as approvals are still pending from West Australian Planning Commission. No works have been started until the necessary approvals are received.

Proceeds from the disposal of assets

10. The variance of \$324,941 relates to the delay in disposing of the property located at 514 Kalamunda Road. Survey and valuation works were completed in the month. The sale is expected to occur in 2015/2016.

Capital Expenditures

- 11. Infrastructure projects made up of roads, drainage, footpaths, car parks and parks and ovals is underspent by \$2,487,881. This variance is principally emanating from:
 - Parks and Ovals and Roads categories and relates to the two significant projects currently in Hartfield Park and Kostera Oval, \$523,539;
 - On roads, works on
 - Dawson Avenue have not started, \$440,735;

- Hale Road has not yet progressed on \$374,684. Land and building capital category was also under budget by \$706,308, most of this relates to the delays in the Hartfield Park project.

To allow for these projects to reach completion, an amount of \$4,003,345 has been transferred to Unexpended Capital Works and Specific Purpose Grants Reserve.

Rates revenues

12. Rates generation is just over budget with a variance of \$12,137. The rates revenue takes into account \$491,361 related to prepaid rates for 2015/16 which is required to be recognised as income in the year it is received.

Draft Statement of Financial Activity by Program for the year ended 30 June 2015

13. The overall result comments are as above and generally each Program is within accepted budget except for Recreation and Culture and Community Amenities. Major variances have been reported by Nature and Type under points 7 to 12 above.

Draft Statement of Net Current Funding Position as at 30 June 2015

- 14. The commentary on the net current funding position is based on comparison of the draft June 2015 year to date actuals with June 2014 year to date actuals.
- 15. Net Current Assets (Current Assets less Current Liabilities) show a positive result of \$14.6 million. The un-restricted cash position has a positive balance of \$9.3 million which is higher than the previous year's balance of \$7.7 million. This can mainly be attributed to issues addressed above in relation to delays in infrastructure works projects and operational costs.
- 16. Trade and other receivables comprise of rates and sundry debtors totalling \$2.63 million outstanding.

The rates balance has reduced by \$154,577 to \$440,349 in the month due to the direct debit arrangements and transfer of deferred rates of \$58,788 to long term receivables. This represents a collection rate to date of 98.7%.

Receivables Other represents \$1.9 million with the bulk made up of:

- \$500,000 due from Western Power as a contribution for the underground power project;
- \$544,655 related to prepayments made to IT licences, lease payments and subscriptions; and
- \$402,824 related to GST purchases that will be claimed as a refund from the ATO in July 2015.

- 17. Sundry debtors have reduced to \$235,232 of which \$176,806 is made of current debt due within 30 days.
- 18. Provisions for annual and long service leave are stable at \$2.2 million. The Shire aggressively pursues a leave management plan that will not adversely affect service delivery. The long term goal is to bring this liability down to a more manageable level and also ensure that there are adequate reserves in place to support it.
- 19. Restricted Reserves have increased significantly to \$11.2 million. This is higher than the budgeted amount of \$7.8 million.

The main variance is made up of:

- Unexpended capital projects in land and property resulting in less withdrawal of funds, \$885,383;
- \$4 million relating to the carry forward of capital works besides land and buildings which are now carried forward into 2015/16; and
- \$1.95 million relating to the change of the Forrestfield Industrial Area Scheme Stage 1, now recognised as a Reserve and not a Trust fund.

PURPOSE

1. To consider endorsement of a submission to the Western Australian Planning Commission on *Perth and Peel@3.5million* and *North-East Subregional Framework.*

BACKGROUND

- 2. On 1 May 2015, the Western Australian Planning Commission released *Perth* and *Peel@3.5million* for public comment. Included with it was the *North-East Sub-regional Framework*. These two documents provide the strategic direction for the growth of the Perth and Peel regions over the next 35 years.
- 3. The draft *Perth and Peel@3.5million* and *North-East Sub-regional Framework* defines where the population growth can be best accommodated, where supporting employment options should be located and where areas of significant environmental value should be avoided and protected. The two documents also identify population forecasts, infill development targets and, most importantly, land for future development.
- 4. The Sub-regional Framework, once adopted, will be converted into a Subregional Structure Plan. This Structure Plan will inform future Metropolitan Region Scheme amendments and Local Planning Scheme amendments. Because the Structure Plan is proposed to guide planning until 2050, it is important that Council's views are represented during the current advertising process.

DETAILS

- 5. The Shire has prepared a submission to the draft documents, included as Attachment 1.
- 6. The Shire has numerous issues with draft *Perth and Peel@3.5million* document. The document has been created with practically no input from local government or the development industry and appears to have omitted numerous development opportunities within the Shire.

- 7. The Shire has concerns regarding the methodology employed and the lack of transparency demonstrated in how conclusions were determined. Further the Shire has raised issues regarding the need for Developer Contribution reform, the focus on inner urban outcomes and the implementation of the proposed plan.
- 8. Of particular concern is the lack of consideration of demographic factors, specifically aged care. The draft documents provide no guidance on a number of issues surrounding aged care such as location of regional facilities, built form guidance, location of services, and dwelling targets. The Shire recommends the document be amended to ensure that these important issues are addressed as a priority.
- 9. The supporting Sub-Regional Framework illustrates the location of future development areas within the Shire. The document consists of a map, which shows all potential development land until 2050, and a text that justifies and provides a background to the map. The map is at a high-level, meaning it separates Urban, Rural, Industrial and Parks from each other, but it does not discern residential, retail, agriculture, or other Local Planning Scheme zones.
- 10. Up until now, there has been practically no involvement of Local Governments in the Sub-regional Framework, and no involvement from the public. The Department of Planning, along with their private consultants, formulated the draft Framework and are requesting comment, rather than engaging with Local Governments from the start to get the best outcome. As a result, the Department of Planning has missed vital opportunities within our Local Government Area, which would have been included if the Shire were consulted.
- 11. The draft *North-East Sub-regional Framework* excludes six key locations from an Urban classification, indicating that they should remain Rural:
 - 1. Foothills Investigation Area
 - 2. Wattle Grove South
 - 3. Pickering Brook Townsite Expansion Area
 - 4. Carmel Investigation Area
 - 5. Croxton Road Investigation Area
 - 6. Maddington Kenwick Strategic Employment Area (MKSEA)
- 12. All of the above areas are proposed Urban in the Local Planning Strategy with the exception of MKSEA, which is shown as future Industrial. By illustrating all of these developable areas as Rural in the North-East Sub-regional Framework, the Department of Planning is contradicting their previous endorsement of the Shire's Local Planning Strategy.

14. The Local Planning Strategy should be consistent with the North-East Subregional Framework. If the Framework is not modified, then the Local Planning Strategy will need to be amended.

18. If approved, the development options and range of property types within the Shire will be limited, in favour of further development in less appropriate locations. 19. A number of locations in the Shire's Local Planning Strategy have been omitted, which will reduce the Shire's long term projected population. The resultant smaller population will reduce opportunities for local employment and have a detrimental impact on the future prosperity of the Shire.

20. Future planning mechanisms will identify environmental risks as a result of these proposed documents.

OFFICER COMMENT

22. The draft framework states that areas identified for development have been chosen using several criteria, including:

- Environmental issues;
- Bushfire risk;
- Infrastructure availability; and
- Employment self-sufficiency.
- 23. Since the 6 areas identified earlier in the report were not included, the Shire could only assume that the areas did not satisfy one or more of the above criteria. As part of the Shire's submission, the Shire engaged three private consultants to investigate environmental issues, bushfire risk and infrastructure availability. All three investigations showed that there were no constraints to developing the 6 areas. The Shire can only conclude that the Department of Planning's consultants did not research as much detail and missed the opportunities of these areas.
- 24. The final criterion is employment self-sufficiency, which is the locating of employment opportunities near where people live. The Local Planning Strategy already goes into detail to explain the significance of this measure and how it is satisfied through the Local Planning Strategy's recommendations. The Shire reiterates this point in the drafted submission without further investigation being necessary.
- 25. By using the above justification, the Shire's submission (Attachment 1) requests the Department of Planning to show areas 1, 2 and 3 as Urban Expansion, areas 4 and 5 as Urban Investigation, and area 6 as Industrial Expansion.
- 26. The Shire in concerned that the State Government has identified local government as being a responsible agency for 45 of the 50 actions in the plan. As local government has had almost no involvement in the development of the plan, and documents such as endorsed Local Planning Strategies are ignored, the Shire must demonstrate its disappointment in the final product and request that the government instead work constructively with local government to achieve a better outcome.

PURPOSE

1. To consider Councils response to the possibility of the introduction of rate capping for local governments in Western Australia.

BACKGROUND

2. At the Ordinary Council meeting of 25 May 2015 Council passed the following resolution in response to a councillor Notice of Motion:-

RESOLVED OCM 58/2015

That Council:

- 1. Requests the Chief Executive Officer to investigate and prepare a Report for Council consideration.
 - (a) Whether recent reports that the State Government is moving to implement rate capping for local governments is correct and if an implementation date has been determined.
 - (b) Possible options or increased funding from the State Government to offset the impact of rate capping and the cost to local government of previous functions of the State now being undertaken by local government, including direct funding of staff salaries.

3. Rate-Capping

The term 'rate-capping' or 'rate-pegging' refers to the imposition of a ceiling or allowable limit on a percentage rate increase from year to year. A cap can be applied either to a local government's budgeted revenue or to the levied ratein-the-dollar itself. Presuming the cap is low, rate-capping can be effective in protecting ratepayers from significant increases in their Rates Charges.

In Australia, rate-capping is only imposed upon local governments in New South Wales, where it has been in use since 1977. The New South Wales Government enforces a percentage limit by which all local governments may increase their

total income derived from Rates Charges. The rate-capping percentage is set each year by the Minister for Local Government.

A similar system exists in Queensland, where local governments can choose to cap the levied Rates Charges by a stated percentage. Queensland differs from New South Wales however, in that the limit is not imposed upon Councils by the State Government, enabling Queensland local governments to retain greater autonomy in their financial decision-making. Within the constraints of existing legislation, the Shire of Kalamunda could self-impose a rate-capping limit, similar to local governments in Queensland. However, if the Shire aspired to a system similar to that in New South Wales, some amendment to existing legislation would need to be sought.

• Advantages:

State-Imposed (eg: NSW):

Under a rate-capping system, ratepayers would be protected from significant increases in Rates Charges that result from triennial property valuations (presuming the rate-cap were low). Under the Rates and Charges (Rebates and Deferments) Act 1992, the rebate or deferment that is currently available for Seniors and Pensioners, (who hold a concession card), could still be applied to this method of rating.

This method of rating continues to utilise the current system of property valuations based on the GRV. The GRV is derived from the income that could be raised if the property were offered for lease and therefore has some relation to the ability of the ratepayer to pay.

Self-Imposed (eg: QLD):

As above

Scope already exists within current Western Australian legislation for the self-imposition of a rate-cap and it would not be necessary for the Shire to seek a legislative amendment, a process which can be protracted.

• Disadvantages:

State-Imposed (eg: NSW):

A rate-capping system administered by the State Government could severely diminish the autonomy of local government, particularly in financial decision-making.

A blanket rate-capping limit imposed by State Government would not take into account regional variations in price movements, (such as between metropolitan and rural areas).

A rate-capping limit imposed upon local governments could be vulnerable to the political expedience of State Government. Under a State-imposed rate-capping system, the overall income from Rates Charges could be considerably lower and could severely restrict a local government's purchasing decisions. In particular, if the initial (precap) rating level is not high enough when the rate-cap is imposed, then the Shire could struggle to adequately provide services and infrastructure to residents if the population continued to grow, (or if the population changed significantly in composition).

In order to generate the income required to be raised from Rates Charges, a portion of the rate burden would likely be distributed to other ratepayers, (ie: while some ratepayers would be charged less, other ratepayers would be charged proportionately more).

A State-imposed rate-capping system does not currently exist within Western Australian legislation and it would be necessary for the Shire to seek a legislative amendment, a process which can be protracted.

Self-Imposed (eg: QLD):

A self-imposed rate-capping limit would be set by the Shire and not by a third-party. As such, it would be largely meaningless as it would likely be based upon the Shire's proposed Annual Budget.

In order to generate the income required to be raised from Rates Charges, a portion of the rate burden would likely be distributed to other ratepayers, (ie: while some ratepayers would be charged less, other ratepayers would be charged proportionately more).

Rate-capping would not alter the underlying method of rating which is based on GRV property valuations. As such, it does not represent a significant philosophical break from the current method of rating used in Western Australia. Notwithstanding, the potential implications of ratecapping are far-reaching and could represent considerable loss of decisionmaking autonomy for local government. It should be noted that ratecapping is considered to be an extremely limiting method of rating, with local governments in New South Wales having been actively calling for its abolition for several years.

DETAILS

- 4. This report deals specifically with the rate-capping issue as a consequence of press reports on 16/17 July 2015 with respect to statements by the Premier expressing concern at the level of rate increases being imposed by many metropolitan local governments in 2015/16.
- 5. Currently under the provisions of the Local Government Act 1995, the Chief Executive Officer has a statutory responsibility to employ, dismiss and manage staff. It is considered that the issue of the payment of staff salaries by the State Government would need legal advice from a constitutional lawyer and expenditure for such advice was not contemplated in actioning the decision of Council.

6. Following the publication of an article in the West Australian on Thursday 16 July 2015, the Premier is quoted as being dissatisfied with the number of local governments within the metropolitan area, particularly smaller ones, that have either adopted or proposed Rate increases well above the current Perth CPI figure of 2.5%. The following table of Rate increases was published in the article:-

Comments attributed to the Premier indicate that this level of rate increases are untenable and are symptomatic of smaller local governments being unstainable and therefore amalgamations of local governments should be considered and driven by the community.

- 7. Whilst there is no specific details of the Premiers proposed rate-capping model, the CPI figure seems to be the main focus. It should also be noted that the Labor Party went to the last election, with a rate-capping policy of Perth CPI plus 2%, and which is still its policy.
- 8. The Shire's 10 year Long Term Financial Plan includes proposed rate increases averaging 3.5% plus a growth component of 1.5% per year.

STATUTORY AND LEGAL CONSIDERATIONS

9. The Shire is required to comply with all provisions of the *Local Government Act 1995* (the Act), which currently does not provide for rate-capping. The introduction of rate-capping would therefore require an amendment to either the Act of the associated *Local Government (Financial Management) Regulations 1996.*

POLICY CONSIDERATIONS

11. Community engagement has not been undertaken with respect to this Report, but would be required if rate-capping is introduced.

12. Depending on the limit imposed under any rate-capping proposal, there could be considerable impact on the Shire's ability to raise sufficient revenue through rates to fund the services and facilities expected by the community.

OFFICER COMMENT

- 18. The utilisation of the standard CPI figure as the basis for rate-capping is considered inappropriate because the items included to determine the CPI rate bear little or no resemblance to the goods and services procured by a local government compared to ordinary consumers. In addition, it does not take into account the increases in costs for state government services past onto local governments.
- 19. Such a proposal would only add to the significant burden imposed on local government over more than two decades of "cost shifting", whereby local governments have had to assume more and more responsibilities for services previously provided by the state.
- 20. There is also evidence that the introduction of rate-capping by other state governments has caused issues for local governments in those states in being able to raise sufficient revenue through rates to provide the level of services and facilities expected by their communities.
- 21. The possible introduction of rate-capping has the potential to severely impact the prime untied revenue raising capacity of the Shire with consequential impacts on the provision of services and facilities. In view of this it should be vigorously opposed.
- 22. It is understood that the WA Local Government Association is also strongly opposed to any rate-capping proposal and will advocate on behalf of local government against its introduction.
